[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On November 16, 2010, a severely malnourished, female Lab mix was seized by Animal Cruelty Investigator, Tracy Saylor from 501 Chinas Cove #D, Ft Walton Beach. The dog was tied up inside of a privacy fence and had no food or shelter. The dog was near death at the time of seizure due to the extreme malnutrition and exposure to the rain and cold of the previous evening. An examination by DVM Soroken showed that there was no clinical reason for the animal to be at the pitiful weight of 16.5 pounds. He states that her extreme anemia and emaciated condition are the direct result of starvation. She was weighed daily for the next two weeks after being given only wholesome food and water. She weighed a total of 32 pounds on November 29, twice what she had weighed at her intake on November 16.

The owner/caregiver for the animal is identified as Denver Colin. He made contact with me after the seizure of the animal. He volunteered the information that he had been taking care of the dog after his mother moved away, several months prior, due to illness. He has been living in Destin and had been really busy with EOD school. He said that he simply "forgot" about providing for the dog, leaving her tied in the rear yard with no food, water, or shelter.

Based up the facts, physical evidence, and voluntary statements in this case, I have reason to believe and do believe that Denver Colin did commit the offenses of Animal cruelty and Confinement without Sustenance in violation of F.S.S.
