HOMEOWNER'S SURVEILLANCE VIDEO HELPS OCSO NAB CAR BURGLAR



An 18-year old Crestview resident is charged with multiple car burglaries in the Brook Drive and Border Creek Road areas of Crestview.

More than a half dozen cars were targeted around the July 20th timeframe. One of the victims had surveillance video that showed an individual entering a car on Brook Drive and taking a GPS unit.

Deputy Korey McDaniel was able to use the video to identify 18-year old Skylar Feagin of 5301 Hare Street as the suspect. Feagin has now been charged with six additional vehicle burglaries involving the thefts of more than 37-hundred dollars in property. Stolen items from the car burglaries include a firearm, knife, diamond earrings, and prescription drugs.

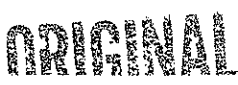

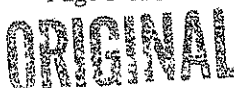

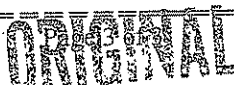

During my subsequent investigation of those cases, I determined this offense had occurred around the same timeframe of several other vehicle burglaries in the immediate area. I was able to develop several leads through the use of the surveillance video obtained from a separate victim.

An intelligence BOLO was given out with the suspect's picture and possible information. This Bolo generated further leads and witnesses. I spoke to the witnesses generated by my investigation.

Based on this investigation and sworn witness statements, the suspect was positively identified as Skylar F. Feagin as the person entering the vehicles. Per video, on 07/20/11 at approximately 0030 hrs, the surveillance video showed Feagin

Several of the witness provided me some information that Feagin was bragging about stealing and selling the firearm. Another witness gave a sworn statement stating he observed Feagin sell the firearm to another subject because he knew it was "hot".

During a post Miranda interview with Feagin, he denied all the allegations despite being identified by multiple witnesses. Feagin also signed a written consent to search his cell phone. In the phone, messages were found which detailed Feagin's messages to several individuals attempting to sell the Glock. There were specific references to the firearm and the messages were to other witnesses. Those witnesses gave sworn statements detailing Feagin's unlawful sale of the stolen firearm.

Based on the aforementioned information, I have reason to believe and do believe that Skylar F. Feagin violated the following Florida State Statutes; F.S.S 812.02.4, Burglary to a conveyance, to wit: he entered a vehicle without permission with the intent to commit a crime within; and F.S.S 812.014.2c1, Grand theft, to wit: he unlawfully deprived the owner of the benefit of the property in an attempt to gain from the property stolen; and 812.019.1, Dealing in stolen property, to wit: he was trafficking in property he knew was stolen by selling the firearm to a third party. 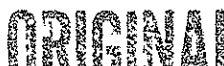
