## "OPERATION SAFE STREETS" UPDATE

An ongoing investigation led by the Okaloosa County Sheriff's Office Street Crimes Unit has currently led to the arrests of thirty-nine suspected street drug dealers across South Okaloosa County and six other individuals involved with prostitution. In addition, the unit has seized two vehicles

The undercover operation dubbed "Operation Safe Streets" came in response to citizen's complaints regarding drug dealers and prostitutes operating in the Sylvania Heights area. Once underway, the operation grew to include other areas within South Okaloosa County.

Special Operations Commander Capt. Tony Wasden said tips from the public have also been playing a pivotal role in the Unit's success.

The prostitution sting, dubbed "Operation Midnight" targeted call girl prostitutes operating in the Destin district, including the operators of an escort service "HotDestinGirls" that advertised in an on-line publication. Investigators also arrested 51-year old Emory Glynn Foster of 109 Alden Drive in Fort Walton Beach on charges of procuring for prostitution, living off the earnings of prostitutes. [ STATEMENT OF PROBABLE CAUSE / NARRATIVE

On 1/21/11 at approximately 0035 hours, Velma Hare committed the offense of Prostitution Third or Subsequent Offense on Tilden Ave. in Ft. Walton Beach, Florida.

The Okaloosa County Sheriff's Office Street Crimes Unit conducted a prostitution sting operation in the southern area of Okaloosa County Florida utilizing a Confidential Informant. The Sheriff's Office Confidential Informant arrived in the area of Tilden Ave. and Lovejoy Rd, and made contact with a female, later identified as Velma Hare.

During this contact, Hare offered to perform oral sex (head) in exchange for twenty dollars. This offense was recorded on audio and video surveillance equipment.

Post-Miranda, Hare admitted to offering oral sex in exchange for money and advised she had been arrested numerous times before for prostitution

Hare has been previously convicted of prostitution offenses in Okaloosa County Florida on at least three occasions. Based upon the aforementioned information, I have reason to believe and do believe that the Velma Hare violated F.S.S. 796.07 (2e) Prostitution third or subsequent offense.

On 1/26/11 at approximately 2337 hours, Christina Chenault committed the offense of Prostitution at a local motel in Destin, Florida.

The Okaloosa County Sheriff's Office Street Crimes Unit conducted an investigation targeting "call girl" prostitutes. An undercover officer placed a call to an escort service that advertised in an online publication and requested a female to arrive at a certain room of the hotel. The individual on the phone stated the charge would be \$250.00. Less than one hour later, Chenault arrived at the hotel and knocked on the room agreed upon. Chenault offered to perform sex in exchange for \$250.00.

Chenault was then placed under arrest and advised of her rights per Miranda. She stated she has done this before a few times without being caught.

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On 1/27/11 at approximately 0005-0210 hours, Emory Foster committed the offense of Deriving Support from the Proceeds of Prostitution.

The Okaloosa County Sheriff's Office Street Crimes Unit conducted an investigation targeting "call girl" prostitutes. An undercover officer placed a call to an escort service HotDestinGirls that advertised in an online publication. The undercover officer then requested a female to arrive at a certain room of the hotel. The male on the phone advised a female named "Amber" would call back. A short time later "Amber" called and then arrived at the hotel room the undercover officer advised. "Amber" then offered to perform oral sex in exchange for money.

During a post arrest interview with "Amber," she advised that Foster was her boss and he sent her to the hotel to perform sex for money. "Amber" was then to pay \$100.00 of the \$250.00 sex fee to Foster. Foster was the person who dropped her off and was supposed to pick her up. "Amber" then called Foster to come pick her up. When Foster arrived, "Amber" identified him as the person who derives money from her prostitution.

"Amber" advised that Foster has several girls that work for him and they are expected to have sex with clients or they will be unemployed. He always expects thirty percent from the proceeds of their prostitution. "Amber" stated the majority of Foster's income comes from this illegal enterprise. "Amber" has worked for Foster for three months and has performed sex acts in exchange for money and then given a portion of the proceeds to Foster on several occasions while he had full knowledge from where the money comes.

Foster was then arrested and an inventory of his truck revealed two cell phones. D/S Rader called the same phone number listed as the HotDestinGirls advertisement and one of Foster's phones began ringing and displayed D/S Rader's phone number. The undercover officer identified Foster's voice as the same he initially spoke to when he called HotDestinGirls.

Based upon the aforementioned information, I have reason to believe and do believe that Emory Foster violated F.S.S.796.05 Deriving Support from the Proceeds of Prostitution.

On 1/27/11 at approximately 0005-0210 hours, Emory Foster committed the offense of Deriving Support from the Proceeds of Prostitution.

The Okaloosa County Sheriff's Office Street Crimes Unit conducted an investigation targeting "call girl" prostitutes. An undercover officer placed a call to an escort service HotDestinGirls that advertised in an online publication. The undercover officer then requested a female to arrive at a certain room of the hotel. The male on the phone advised a female named "Amber" would call back. A short time later "Amber" called and then arrived at the hotel room the undercover officer advised. "Amber" then offered to perform oral sex in exchange for money.

During a post arrest interview with "Amber," she advised that Foster was her boss and he sent her to the hotel to perform sex for money. "Amber" was then to pay \$100.00 of the \$250.00 sex fee to Foster. Foster was the person who dropped her off and was supposed to pick her up. "Amber" then called Foster to come pick her up. When Foster arrived, "Amber" identified him as the person who derives money from her prostitution.

"Amber" advised that Foster has several girls that work for him and they are expected to have sex with clients or they will be unemployed. He always expects thirty percent from the proceeds of their prostitution. "Amber" stated the majority of Foster's income comes from this illegal enterprise. "Amber" has worked for Foster for three months and has performed sex acts in exchange for money and then given a portion of the proceeds to Foster on several occasions while he had full knowledge from where the money comes.

Foster was then arrested and an inventory of his truck revealed two cell phones. D/S Rader called the same phone number listed as the HotDestinGirls advertisement and one

of Foster's phones began ringing and displayed D/S Rader's phone number. The undercover officer identified Foster's voice as the same he initially spoke to when he called HotDestinGirls.

Based upon the aforementioned information, I have reason to believe and do believe that Emory Foster violated F.S.S.796.05 Deriving Support from the Proceeds of Prostitution.

This incident occurred in Okaloosa County Florida where I am a sworn law enforcement officer.

On 1-26-10, an investigation into prostitution was initiated in the Destin district by members of the Okaloosa County Sheriff's Office Street Crimes Unit. I, D/S Foster working as an undercover officer, placed to calls "call girls" taken from online escort service advertisements.

Once calls were placed, the escort was given the name and location of the hotel/motel as well as the room number. The purpose of conducting this operation was to make contact with a female escort/prostitute and allow her to negotiate sexual activities in exchange for money.

Once the female arrived, casual conversation was initiated allowing the female to suggest the sexual act and how much she would charge.

At approx 12:05am, I placed a call to Destin Hot Girls. A male, later identified as, Emory Glynn Foster aka "Bo" answered. I asked if this was Destin Hot Girls and he acknowledged. I stated to him that I saw the online ad and asked if "Amber" was available. The male replied "yes" and asked if the number I was calling from was one that she could reach me. I stated that it was. The male acknowledged "Amber" would call me back.

At approximately 12:11am, "Amber", later identified as, Stephanie Anne Johnson called. I informed her that I was in Destin and gave my specific location then asked if she was available. "Amber" stated yes." Amber" further stated she was in Niceville and it would take approximately 45 minutes to arrive because she had to get dressed.

At approximately 1:19am, I received another call which "Amber" stated she would be arriving in 2 minutes.

At 1:25am, "Amber" arrived. Upon making contact at the door, "Amber" acknowledged she was who I had spoken to. Once inside, I initiated casual conversation. "Amber" stated that she used to be a dancer at The Matador but she got fired after being caught snorting a crushed pill. I replied that I worked as a contractor on Eglin Air Force Base and could not risk being exposed.

Conversation then switched to fees. "Amber" stated that her fee would be \$250.00

for everything but that she did not like "anal". I told her not to worry because I didn't like that either. "Amber" further stated that she could give me a "blowjob" but I'd have to be clean. "Amber" then stated she needed to be paid first after which I gave her \$250.00 in recorded money. After receiving the money, "Amber" placed a phone call to "Bo" and stated that "everything was good".

"Amber" placed the money in her pants pocket and turned the lamp off inside the room. "Amber" then began to unbutton her pants as she walked over to turn the room heater on. As she walked over to the bed, members of the Okaloosa County Street Crimes Unit, who were monitoring the conversation via audio surveillance, entered the motel/hotel and took "Amber" into custody.

During a search of "Amber's" person, a syringe was discovered in her purse.

During a post arrest interview with "Amber," by D/S Roberts, she advised that Foster was her boss and he sent her to the hotel to perform sex for money once he received a phone call requesting her. After performing the sexual act, "Amber" was then to pay \$100.00 of the \$250.00 sex fee to Foster. "Amber" stated that Foster was the person who dropped her off and was supposed to pick her up.

"Amber" further advised that Foster has several girls who work for him and they are expected to have sex with clients or they will not be unemployed by him. He always expects thirty percent from the proceeds of their prostitution. "Amber" stated the majority of Foster's income comes from this illegal enterprise. "Amber" stated she has worked for Foster for three months and has performed sex acts in exchange for money. After being picked up, "Amber" then gives a portion of the proceeds to Foster who has full knowledge where the money comes from. "Amber" also explained that Foster requested the girls call him on his cell phone once they received the money from the John she stated, Foster receives thirty percent of what we make on a call." D/S Roberts asked Amber if she knew if Foster" was employed anywhere else. "Amber" said she thought he was a painter but Foster had made comments to her that the painting business was slow because of the economy and he was getting all of his money from his escorts.

"Amber" described Foster as a middle aged white male who was overweight and had facial hair. "Amber" made a phone call to Foster's cell phone, with D/S Roberts present, to come and pick her up. Shortly after "Amber" made the phone call to Foster's cell phone, a silver/gray dodge pickup truck pulled into the parking lot of Motel 6 and parked in front of units 101 and 103. "Amber" looked out of the motel window and positively identified the driver of the silver/gray pick up as Foster.

Foster, who was later identified by his Florida Driver's license, was placed under arrest. A document with male names and numbers was located in Foster's vehicle. Beside several of the male's names was written 1 girl or 2 girls. I identified this sheet as clients who had called to request escorts from Foster's business, Destinhotgirls.com.

The Dodge Ram pickup was towed to the Fleet Maintenance Bldg by C&B Towing.

Foster was arrested for violating F.S.S. 796.05, Procure for Prostitute Live off Earnings of Prostitute and transported to the Shalimar Annex for booking.

Johnson was transported to Shalimar Annex Booking and given a Notice to Appear in lieu of Physical Arrest for violating F.S.S. 796.07(2) (E) Prostitution and F.S.S. 893.147 Possession of Paraphernalia.
