On 01/22/11 I responded to Petland regarding a theft. Upon arrival contact was made with owner, Glen Wentworth. Wentworth advised today at closing time employees noticed that one of their parrots appeared to be missing. The parrot, a Yellow Nape Amazon, valued at \$1,499 had not been sold, and the employees immediately contacted Wentworth.

Upon review of the day's surveillance video Wentworth discovered the parrot had been stolen at approximately 1500hrs. Wentworth, who completed a sworn Affidavit of Complaint, stated on reviewing the video he observed a white male with brown hair, wearing a white shirt and blue jeans could be seen looking at and playing with the parrots in their pen. Wentworth stated at one point it appeared the suspect held the birds side by side as if comparing and choosing which he preferred. The suspect then went to an aisle where he selected a pet carrier, designed to fit cats or other animals of a smaller size, and placed the bird into the carrier. The suspect then walked out the front door of the store without attempting to render payment for the carrier (valued at \$29.99) or the concealed parrot. None of the employees appeared to have noticed the individual during the time this occurred.

Wentworth stated that during his review of the video it appears as if there are possibly 2 females, one adult male, and a male juvenile who have interaction with the suspect while he is in the store. Wentworth stated it is possible that although they departed at different times, the video made it appear as if all of these subjects were together and the others were possibly distracting the employees at the time of the theft. Wentworth made a copy of the surveillance video and provided it on a thumb drive along with notes he made regarding the suspect and possible accomplices actions. The surveillance video, still photos and notes provided by Wentworth will be placed into evidence.

On 01/23/11 I was contacted by Wentworth who claimed to have received information that an individual in Pensacola was attempting to

expressed an interest in the bird he told her that he was looking to sell the bird and inquired as to if she knew of anyone who would be interested. Beck stated the subject was merely exchange merchandise so the store would not have requested any information however she stated the store did have surveillance video which would have captured his time in the store. Beck stated she had never seen the subject in the store previously.
