STOLEN CARS INVESTIGATION LEADS TO TWO MORE ARRESTS

Deputies with the Okaloosa County Sheriff's Office have made two additional arrests in connection with an investigation into multiple car thefts in Destin and Okaloosa Island. They have also recovered a fourth stolen vehicle.

19-year old Allan Morgan of Destin is now charged with grand theft auto and resisting arrest without violence. Morgan, who had been developed as a suspect, was found walking on Bent Arrow Drive in Destin this morning (Thursday, July 21st). He admitted to being a passenger in a stolen car Wednesday and fleeing from law enforcement officers attempting a traffic stop on Lola Circle. Morgan admits being present when the car was taken from the Emerald Grande Condominiums parking garage on July 20th.

Also arrested in connection with the investigation is a sixteen-year old Destin resident who admits being a passenger in the stolen car Wednesday and fleeing from deputies. That teen is charged at this time with possession of marijuana and resisting arrest without violence.

The driver of the stolen car, 19-year old Scott Haslam, was arrested Wednesday at the scene. (See previous release.)

In addition, OCSO investigators have recovered stolen property and their investigation is continuing.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

Between 07/19/2011 at 2300 hours and 07/20/2011 at 1000 hours, a vehicle theft occurred at The Emerald Grand Condominiums, located at 10 Harbor Boulevard, Destin, Florida. The vehicle reported stolen was a white 2005 Toyota Avalon, bearing Louisiana tag #NZE865 (VIN#4T1BK36B95U005092). The vehicle was parked inside the parking garage at this location. The vehicle was left unsecure with the keys inside the vehicle. The estimated vehicle value was \$25,000.00.

On 07/20/2011 at approximately 1410 hours, I parked in the parking garage behind 543 Harbor Boulevard,

Destin, Florida. I observed a white 2005 Toyota Avalon, bearing Louisiana tag #NZE865 (VIN#4T1BK36B95U005092) driving through the parking garage. Due to taking the initial report of this incident, I knew that vehicle to be the vehicle that was stolen. The vehicle exited the bottom floor of the parking garage and it turned northbound on Benning Drive. Deputy Rice and I attempted to conduct a traffic stop on the vehicle at Benning Drive and Mountain Drive. The driver of the vehicle, Scott Haslam, began accelerating the vehicle rapidly as it turned eastbound onto Mountain Drive. Haslam drove eastbound on Mountain Drive, failing to stop at the stop sign at the intersection of Mountain Drive and Sea Oats Drive. The vehicle drove through the intersection of Mountain Drive and Beach Drive, failing to stop at the stop sign at the intersection of Mountain Drive and Beach Drive. The vehicle drove across Beach Drive and began driving eastbound on Lola Circle. As the vehicle approached 167 Lola Circle, all of the vehicles doors opened and all five of the occupants got out of the vehicle and ran. Haslam ran westbound through the yard of 167 Lola Circle. As Haslam attempted to climb the rear privacy fence of 167 Lola Circle, I was approximately six feet behind Haslam. I utilized by taser and I discharged one cartridge into Haslam's back. Haslam was subsequently taken into custody without further incident. During this entire incident, I was driving a marked Okaloosa County Sheriff's Office patrol vehicle with my emergency lights and siren activated.

Post Miranda, Haslam stated on 07/20/2011 at approximately 0200 hours, he was at The Emerald Grand Towers. While at The Emerald Grand, Haslam was "car hopping" which is short for checking door handles. Haslam located the above listed vehicle on the fifth floor of the parking garage. The keys to that vehicle were in the vehicle. Haslam stated he stole the vehicle and went "joy riding" with several friends in the Destin area. Upon the Sheriff's Office attempting to stop the vehicle, Haslam panicked and attempted to evade the Sheriff's Office in the vehicle. When Haslam realized that he had drove into a location on Lola Circle that he could not get out of, Haslam and the other occupants got out of the vehicle and attempted to flee on foot. I chased after Haslam and he was subsequently tased and taken into custody.

Based on the information and evidence in this case, there is probable cause to believe and your affiant does believe that Haslam was in violation of Florida State Statutes 812.014(2)(C)(6); Grand theft auto,316.1935(1); Fleeing and eluding, and 843.02; Resisting without violence. Haslam was transported to Fort Walton Beach Medical Center for medical clearance. Haslam was transported to the Okaloosa County Courthouse for processing. DJJ was contacted and advised to transport Haslam to DJJ in Crestview, Florida.

This incident occurred in Okaloosa County, Florida where your affiant is a sworn Law Enforcement Officer.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 07/20/2011 at approximately 1410 hours, Deputy Hehl attempted to stop a white 2005 Toyota Avalon, bearing Louisiana tag #NZE865, which was reported stolen earlier that day. The driver of that vehicle, later identified as co-defendant Scott Haslam fled from Deputies in the vehicle and eventually stopped on Lola Cir in Destin, FL. During the pursuit, Deputy Hehl was driving a marked patrol vehicle and had activated his emergency equipment indicating a lawful order to stop. The vehicle was occupied by four other passengers. All the passengers (3 white males, 1 black male) fled on foot upon contact with Deputy Hehl.

Haslam was captured and rendered a post-Miranda statement regarding the passengers. Two of the passengers were identified as white male [REDACTED] and a black male name Allan. [REDACTED] was later captured and admitted to fleeing from the vehicle during the stop.

On 07/21/2011, Deputy Evans located the defendant, Allan Morgan walking on Bent Arrow Dr in Destin. The defendant agreed to accompany Deputy Evans to the district office for questioning. During a post-Miranda interview, the defendant admitted to being a passenger in the stolen vehicle and fleeing on foot. He also admitted he knew the vehicle was stolen and was present during the theft. The defendant was also found to be in possession of property, stolen during a

vehicle burglary. Other property stolen during that same burglary were key to the stolen Toyota Avalon.

Based on this information, I believe the defendant violated F.S.S. 812.014(2)(C)(6); Grand theft auto (Principle) and F.S.S. 843.02; Resisting without violence. This offense occurred in Okaloosa County, Florida where I am a sworn Law Enforcement Officer.

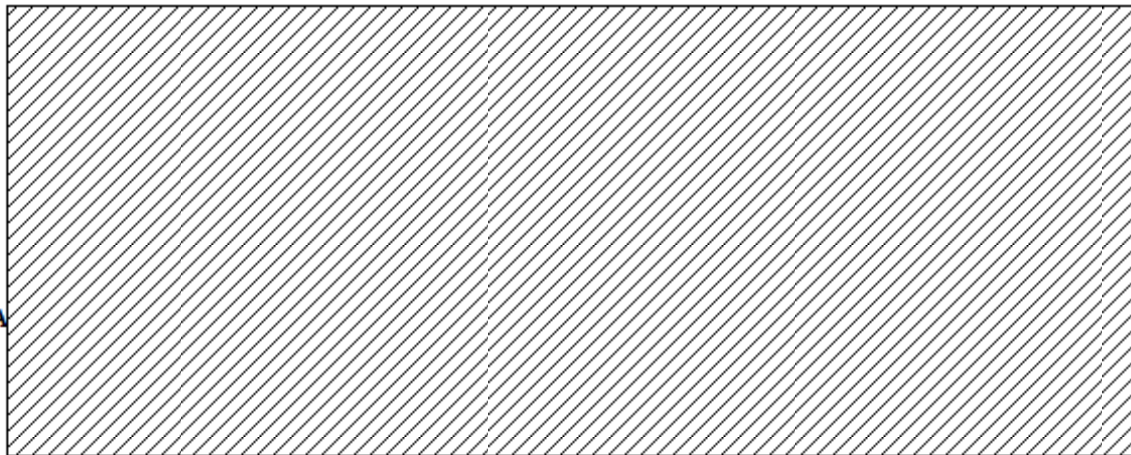
