[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 6/18/11 I responded to Pranzo's Italian Restaurant, 1225 N Santa Rosa Blvd, Ft Walton Beach, FL, in reference to a battery. While enroute I was notified by dispatch that the suspect was still on scene and the situation had escalated with the suspect getting physical and throwing wine bottles.

I arrived on scene to see three subjects running out the front door waving there arms and screaming for help. I observed the front door broken in. I then began hearing windows breaking as the suspect began throwing wine bottles through the windows. I got a visual on the subject, a large white male, and told him to show me his hands and come out of the restaurant. The subject yelled profanities at me and began throwing wine bottles through the broken windows at me. Several of the bottles came close to hitting me and broke under my patrol vehicle. I felt I was going to be hit by a wine bottle so I took cover next to my patrol vehicle and utilized my PA system in an attempt to talk to the suspect. After a few minutes, the suspect came out the front door with his hands up but refused to obey my commands to stop and get on the ground. He began moving towards me aggressively and I advanced on him telling him I would tase him if he didn't get on the ground. At that point the suspect complied and was taken into custody. He was identified as Bryan Case.

Ryan Montalto advised me in a sworn affidavit that he had been working in his restaurant before opening time with two employees when an individual came in the restaurant asking to borrow jumper cables. Montalto further stated when he told the subject he didn't have any cables the subject grew irate and pushed him. At that point Montalto stated he told the subject to leave and locked the door behind him. Moments later Montalto stated he heard glass breaking and ran out to see the same individual breaking through his front door. He stated the subject hit one of his employees in the mouth and then grabbed wine bottles and began throwing them at everyone. Montalto advised one of the wine bottles hit him in the leg. At this point Montalto stated he called 911. Montalto estimated the damage to his store at \$150,000.00.

Dustin Dewrell advised me in a sworn statement that he had been standing near the front door when the suspect kicked it in entering the restaurant the second time. Dewrell further advised the suspect hit him with a closed fist after breaking down the door and entering. Dewrell also advised the suspect had thrown wine bottles at him.

Shannigan Heckenlaible advised me in a sworn statement that he was in the bathroom when the suspect entered. Heckenlaible heard yelling and saw the suspect throwing wine bottles.

I then viewed the damage to Pranzo's with D/S Jeremy Gilbert who took digital photo's of the damage. I observed most of the exterior custom plate glass windows broken out and numerous bottles of wine were broken and scattered all over the restaurant and the parking lot. Multiple wine coolers and other kitchen equipment were damaged as well as sheet rock and interior decorations. Montalto estimated the damage to his store at \$150,000.00.

Based on the above I have reason to believe and do believe that the defendant, Bryan Case, did willfully and knowingly violate FSS 810.02.2a Burglary on Occuppied Structure with Battery; FSS 806.13.1b3 Felony Criminal Mischief; FSS 784.03.1a2 Battery (3 counts); FSS 784.07.2a Assault on Law Enforcement Officer; and FSS 843.02 Resisting Without Violence. These offenses occurred in Okaloosa County where I am a sworn law enforcement officer.
