## PACKAGES OF DRUGS AND CASH SEIZED BY OCSO DRUG TASK FORCE



The Okaloosa County Drug Task Force executed a narcotics search warrant Friday at 873 B Fairview Fort Walton Beach Florida.

Sheriff's Investigators seized cocaine, approximately 20 pounds of marijuana, firearms and drug paraphernalia, as well as a vehicle and approximately \$16,000.00 in cash.

The suspect, Keith Michael Harris 01-04-1982, is charged with possession of cocaine, possession of marijuana with intent to distribute, grand theft of a firearm, possession of a firearm by convicted felon, cultivation of marijuana and possession of drug paraphernalia.

**PROBABLE CAUSE**

On Friday, June 24, 2011, Keith Michael Harris was arrested subsequent to a service of a narcotics search warrant at his residence. This search warrant was the culmination of an investigation that began with a Crime Stoppers Tip originating in May of 2011. On the above date, agents from the Multi-Agency Drug Task Force served a narcotics search warrant at 873 Fairview Drive Unit B, Fort Walton Beach, FL. Harris was located at the residence and detained while a search of his residence was conducted.

During the search of the residence, agents located approximately twenty pounds of field tested marijuana and numerous digital scales indicative of distribution for sale. A marijuana plant was also located in the residence growing within Harris's master bedroom. Lying on the floor beside Harris's bed was a loaded Winchester Colt .45 caliber revolver. Within this same room where Harris was found were numerous large black luggage/duffel bags believed to be used in Harris's transportation of marijuana. These bags contained marijuana residue.

Agents located approximately \$16,000.00 dollars of U.S. Currency within a safe concealed in Harris Laundry room. Documented police drug buy money was commingled within the U.S. Currency. Adjacent to the safe, was a loaded Stoeger 12 gauge shotgun. Agents also found approximately one gram of field tested cocaine which was located within a cigarette pack. Several pill tablets were found in a Ziploc baggie and identified as Lorazepam and Clonazepam. Both of these are schedule four controlled substances and no valid prescription was located in the residence. Assorted drug paraphernalia to include a marijuana smoking device, several scales and baggies was also present throughout the residence.

to believe, and do believe, that the above named defendant, Keith Michael Harris, was in possession of a firearm by a convicted felon, did possess a distribution amount of marijuana, did unlawfully take the property of another without consent, did possess drug paraphernalia and did cultivate of marijuana. These offenses are classified as grand theft, pursuant to F.S.S. 812.014 (2c), possession of marijuana over 20 grams with intent to distribute, pursuant to F.S.S. 893.13(1a2), possession of a firearm/ammunition by a convicted felon, pursuant to F.S.S.
