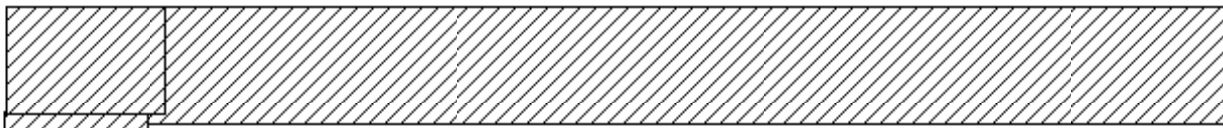

On 2/27/11 I responded to 4201 Indian Bayou Trail Unit 1304, Destin FL in reference to a robbery to a person.

Upon arrival I made contact with Joe Thomas, the victim, who relayed the following information to me in the form of a sworn affidavit of complaint and a verbal interview. Thomas stated on 2/26/11 at 2200 hours he was walking down the airport side of Airport Rd on the sidewalk. Thomas stated suddenly 3 Hispanic males rode up behind him on bicycles. Thomas stated suddenly he was "jumped" by the 3 Hispanic males, 1 of which he immediately recognized as Raul Hernandez, a man he knew worked for a friend of his and had battered him in the past, OCSO report number 11-0077 pertains. Hernandez had only been out of jail for the prior battery on Thomas for a few days. Thomas stated the males knocked him to the ground, began beating his face against the concrete sidewalk and hitting him with a closed fist while yelling "where's your money". Thomas stated the males rolled him over, located his wallet and took his money (\$300). They then threw the wallet on the sidewalk and ran away leaving him lying on the ground.

D/S Jeremy Gilbert responded to my location to assist with my crime scene. Thomas displayed multiple contusions and hematoma's on his face and bloody spots on his knees. D/S Gilbert photographed Thomas's injuries and placed a CD of these photo's into evidence.

I then made contact with Bunnilyn Thomas, the victim's wife. She provided a verbal statement in which she said Joe [REDACTED] Bunnilyn stated that on 02/27/11 at about 2130 hours Joe left Pepito's (Mexican restaurant) on foot supposedly to get cigarettes. Bunnilyn stated Joe left with about \$500 and when he returned several hours later he was bleeding from the face and knees and had less then \$200 on his person. At the time Bunnilyn stated Joe wasn't sure what had happened but stated he remembered a few hours later.

On 02/28/11, I made contact with OCSO Crime Analyst Nicole Wagner in regards to assembling a photo line up for the suspect in this case, Raul Hernandez. Wagner created a photo line up on Hernandez and sent it to my email on 03/01/11.

On 03/02/11 I made contact with the victim in this case, Joe Thomas, in regards to the prepared photo line up. Thomas viewed the line up and then immediately identified Raul Hernandez (#4) as the suspect. When asked how sure he was of his choice Thomas replied 100%. Thomas further circled and initialed his suspect choice.

The photo line up viewed by Thomas was placed in the case file.

On 2/27/11 I responded to 4201 Indian Bayou Trail, Unit 1304, Destin, FL, in reference to a robbery to a person.

Thomas stated suddenly he was "jumped" by 3 Hispanic males, 1 of which he immediately recognized as Raul Hernandez, a man who had battered him in the past. Thomas stated Hernandez knocked him to the ground and began beating his face against the concrete sidewalk and hitting him with a closed fist while yelling "where's your money". Thomas stated Hernandez located his wallet, took his money (\$300) out of the wallet and threw the wallet on the sidewalk. Hernandez and the other suspects ran away leaving him lying on the ground. Thomas displayed multiple contusions and hematoma's on his face and bloody spots on his knees which were documented with photographs.

On 03/02/11, I showed Joe Thomas prepared photo line up which contained Hernandez's picture. Thomas immediately picked Raul Hernandez out of the line up and stated he was 100 % certain that he was the man who battered and robbed him.

Based on my investigation I have reason to believe and do believe that Raul Hernandez did willfully and knowingly violate FSS 812.13.2c Robbery. This offense did occur in Okaloosa County, FL, where I am a sworn law enforcement officer.
