## **FOUR TEENS FACE FELONY CHARGES, FIFTH BEING SOUGHT**

A Destin teen who had been reported missing and was the subject of an active search by the Okaloosa County Sheriff's Office was located this morning in Destin and now faces charges of grand theft auto and burglary to a dwelling.

Deputies were called to 4000 Gulf Terrace Drive around 6:15 Monday morning, May 23<sup>rd</sup>, after a stolen car hit five vehicles in a parking lot there. When deputies arrived, the keys were still in the ignition and witnesses reported seeing people running from the scene after the crash.

Officers made contact with 18-year old Sierra Nicole Mott who told them she and another girl met friends Courtney Coffield and Stephanie Walsh at a home on Marker Cove in Mary Esther. They decided to go "car hopping" or break into cars in Destin. They took the car from the home of Lisa Chomer and picked up another teen, 16-year old Dakota Blankenship before heading out. (Coffield had been reported missing to the Okaloosa County Sheriff's Office after failing to return home from school last Thursday, May 19<sup>th</sup>.) The teens drove to Gulf Terrace Drive and Mott says she, Coffield, and the other girl got out to go break into cars. She later heard tires squealing and the sounds of a collision.

Deputies have charged 15-year old Coffield of Wimico Circle in Destin with grand theft auto and two counts of burglary. Blankenship, a Mary Esther resident, is charged with grand theft auto and trespassing, as is Sierra Mott of Buck Drive, Fort Walton Beach and 16-year old Stephanie Walsh of Cambridge Avenue in Fort Walton Beach .

A 5<sup>th</sup> teen is being sought by the OCSO. Investigators say additional charges are pending.

I have made contact with the owner of the vehicle, Lisa Chomer, who stated that no one had permission to use the vehicle.

In an audio taped non-custodial interview with the co-defendant, Dakota Chase Blankenship, he stated he was picked up in a vehicle which he did not know was stolen. He went to a home in Mary Esther which he knew the residents, the Chomer's, were out of town. He stated they then went to Destin and were going to do some "car hopping". He stated he did not know what car hopping was and did not participate in the vehicle burglaries. After the stolen vehicle was involved in the wreck, he ran from the scene.

I was also able to make contact with Sierra Mott who stated she drove to the residence of Dr. Chomer to meet with Courtney and the others. She stated they hung around at Chomer's house and partied some. They then went to Destin driving the Chomer's 2002 GMC Envoy. While en route to Destin they decided to do some vehicle burglaries and once there, she stated Kalli Carlson, Courtney Coffield and she left the vehicle to commit vehicle burglaries, while Stephanie Walsh and Dakota Blankenship stayed with the vehicle. She stated she knew the vehicle did not belong to Courtney, but belonged to the Chomer's.

During the course of this investigation I was able to make contact Stephanie Walsh. Walsh stated she was called by Courtney Coffield who

In an audio taped non-custodial interview with the co-defendant, Dakota Chase Blankenship, he stated he was picked up in a vehicle which he did not know was stolen. He went to a home in Mary Esther which he knew the residents, the Chomer's, were out of town. He stated they then went to Destin and were going to do some "car hopping". He stated he did not know what car hopping was and did not participate in the vehicle burglaries. After the stolen vehicle was involved in the wreck, he ran from the scene.

During the course of this investigation I was able to make contact Stephanie Walsh. Walsh stated she was called by Courtney Coffield who stated her mother kicked her out and she needed a ride. Walsh and Sierra Mott went to a residence on Bishop Street, Ft Walton Beach, and picked her up. They then went to a home in Mary Esther which was identified as the home of Dr. John Chomer (475 Marker Cove, Mary Esther). Once at Chomer's home all parties entered the home and hung out, with some drinking and smoking of cannabis. She stated they then took the vehicle, 2002 GMC Envoy bearing FL tag AICC26, belonging to Chomer to Destin. Walsh stated she drove the vehicle for Courtney as Courtney said she could use the vehicle. Courtney was not the owner of the vehicle or did she have authorization to allow anyone to use the vehicle. As they were driving to Destin, some of those in the vehicle decided they wanted to do some "car hopping". Stephanie Walsh and Dakota Blankenship stayed in the vehicle. She stated the others went around doing burglaries, at least that was what they told her they were going to do.

I was also able to make contact with Sierra Mott who stated she drove to the residence of Dr. Chomer to meet with Courtney and the others. She stated they hung around at Chomer's house and partied some. They then went to Destin driving the Chomer's 2002 GMC Envoy. While en route
