MAN POSTS ALTERED PHOTOS OF WOMAN ON WEBSITE



David Bruce Slavens

A Crestview man is accused of altering a woman's pictures and placing them on a website created to harass her and her husband.

The Okaloosa County Sheriff's Office has charged 53-year old David Bruce Slavens of 6018 Old Bethel Road with Fraud/Impersonation, distribution of obscene material, and possession of child pornography.

In April 2010, the victim reported that Slavens had created a website called "Where Do Fish Sleep.com" and was displaying images of her without her permission. Some of the images had been altered to appear as if the victim was performing sexual acts. She says Slavens, a former friend, obtained the photos when he did work on her family's personal and business computers.

A search warrant of Slavens home was executed by Investigator Monte Easterday on September 1st, 2010. Items seized were submitted to the Florida Department of Law Enforcement for further examination.

Recovered images included altered ones of the victim similar to those captured off the screen by Investigator Easterday. The FDLE also found thirteen images of known child pornography.

Slavens was arrested November 7th.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 04/21/10 the victim completed an affidavit of complaint before Inv. M. Easterday, stating David Bruce Slavens had created a website, "Where Do Fish Sleep.com", and was displaying images of her without her permission. The victim and her husband state they had previously been friends with David Slavens, but after the friendship had dissolved, David Slavens, without permission, began to place images of the victim on a website he created to harass the victim. The victim and husband stated David Slavens had completed work on computers owned by them personally and through business and stole the images used on the website. Through Inv. M. Easterday's investigation he viewed on the website a booking photo from Okaloosa Department of Corrections, of the victim. The image had been partially altered, but the victim's photo, middle name and date of birth were still displayed on the posting. He also viewed images of the victim that had been altered to look as if she was performing certain sex acts. These were screen captured by Inv. M. Easterday and placed into the case file.

On 08/31/10 Inv. M. Easterday obtained a search warrant for the residence of David Bruce Slavens. The warrant was executed on 09/01/10. Inv. M. Easterday completed a Post Miranda Warning interview of David Slavens during the execution of the search warrant. When presented with the image of partially altered booking photo of the victim, David Slavens stated he obtained it from a public website. He continued he may have done the altering to the photo, but he did post it to the website "Where Do Fish Sleep.com".

Inv. M. Easterday submitted items seized during the execution of the search warrant to FDLE, for further examination.

This Investigator reviewed the report and images recovered by FDLE in regards to the items submitted by Inv. M. Easterday. Contained on Item 7, are multiple images of the victim and her husband. Item 7 contains the booking photo of the victim that was posted to the website and other images of the victim in various clothed and unclothed state. Several of the images appear to be the same images that were altered and placed on the website. The images are contained in multiple folders on the computer that contain "dave" in the file path.

Also recovered from Item 7 by FDLE were 13 images of known child pornography. These images were identified by ICE-CAP (Images of Child Exploitation, Comparative Analysis Program) hash sets. The hash sets were provided by DHS-ICE (Department of Homeland Security - Bureau of Immigration and Customs Enforcement) Cyber Crime Center. One image was maintained on Item 7 in Full Path 20100205752 sub 1 item 7\20100205752 sub 1 item 7 drive A\hda6\dave\movie\lap\1240697998275.jpg - displays an image of a female genitals with what appears to be semen dripping from the vagina. The remaining 12 images were recovered from a deleted folder. In Full Path Item 7\Recovered Files\20100205752 sub 1 item 7 drive A\hda6\dave\Desktop\k\12622802054 - displays an image of a black female holding a young child. The woman is unclothed from the waist up. The young child's right hand is fondling the woman's left breast. In the same file path are other images that depict sex acts or lewd behavior occurring in the presence of children, but the children are not directly participating.

There is probable cause to believe that David Bruce Slavens did violate F.S.S. 817.568 (5) by placing a public record image of the victim on a website he created without her permission; and F.S.S. 847.011 by placing altered images of the victim to portray her in sexual acts on the same website. Both offenses were done in manner to harass her. David Bruce Slavens also violated F.S.S. 827.071(5)(a) Sexual Performance by a Child; by maintaining images of child pornography on his computer.

These offenses occurred at 6018 Old Bethal Road, Crestview, Okaloosa County, FL.
