OCSO SHUTS DOWN RESIDENTIAL METH LAB IN CRESTVIEW

On 10/2/2011, Okaloosa Sheriff's deputies responded to complaints of smoke and strange odors emanating from a suspected methamphetamine lab at 957 B St. in Crestview.

When they arrived at the house, 39-year old Robert McDonald tried to run out the back but was confronted by law enforcement and went back inside.

Other occupants of the house allowed deputies to enter, however McDonald could not be found. Deputies were told of the existence of a trap door in the bathroom that allowed access to underneath the home.

While inside the house, deputies saw items used in the manufacturing of methamphetamine in plain view. McDonald was observed under the house; however continually refused to cooperate with law enforcement.

Okaloosa Drug Task Force Investigators were called to the scene and obtained a search warrant for the methamphetamine lab.

In addition, OCSO Special Response Team members responded to contain and arrest McDonald. After a period of time, a chemical irritant was introduced under the residence and McDonald was taken into custody without further incident.

He is charged with Trafficking in Methamphetamine, Possession of Drug Paraphernalia and Resisting an Officer without Violence.

21-year old Kenneth Ben Williams of 286 N Lindberg, Crestview is charged with Possession of Controlled Substance (Methamphetamine) and Drug Paraphernalia.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On Sunday, October 3, 2011, your Affiant along with members of the Multi Agency Drug Task Force responded to 957 B Street, Crestview, Okaloosa County, Florida to execute a narcotics search warrant. Pursuant to the execution of the search warrant several items relating to trafficking in methamphetamine, drug paraphernalia and in excess of 200 grams

of methamphetamine were located and seized inside 957 B Street.

Seized as a result of the search warrant execution was a Smart Water brand 20 ounce plastic bottle with both liquids, solids and lithium metal commonly referred to as a "One Pot" methamphetamine cook. A subsequent field test was conducted on the liquid inside of the plastic bottle which yielded a positive response for the presence of methamphetamine. The liquid collected from the plastic bottle was in excess of 200 grams of methamphetamine. This plastic water bottle was found inside of a kitchen cabinet.

Also seized were chemical commonly used in the manufacture of methamphetamine. These chemicals included, muriatic acid, crystal drain clear, instant cold packs, Coleman Fuel, Butane refills and empty blister packs of Pseudoephedrine. These chemicals were found in the living room, kitchen and dining areas.

The following drug paraphernalia was also seized; small clear jeweler's baggy, cotton balls, razor blades, plastic water bottles with unknown chemicals, straws which had been cut in length some of which had drug residue inside. These items were found throughout the residence.

Post Miranda statements were obtained from witnesses that identified the defendant, Robert Michael McDonald. Witnesses also stated that McDonald had a plastic Smart Brand water bottle and was shaking the bottle which they further described it as a "meth cook".

Upon law enforcement attempting contact, McDonald hid underneath the floor of residence in the crawl space. McDonald refused repeated verbal commands to exit the crawl space. After several hours of refusing to comply with commands to come out, chemical agents were deployed by the Okaloosa County Sheriff's Office Special Response Team. After a brief period of time McDonald had to be physically extracted from the crawl space.

Based on the investigation, I have reason to believe and do believe the defendant, Robert Michael McDonald, was in violation of F.S.S. 893.135(1)(f)(1) Trafficking in Amphetamine over 200 grams, F.S.S. 893.147(1) Possess Drug Paraphernalia and F.S.S. 843.02 Resisting an Officer without Violence. These offenses did occur in Okaloosa County where your affiant is a full time sworn law enforcement officer.
