OCSO ARRESTS CARJACKING, ROBBERY FUGITIVE

The Okaloosa County Sheriff's Office now has 32-year old John Paul Rashad Wannamaker of Fort Walton Beach in custody in connection with a carjacking in Mary Esther that led to the battery of an 81-year old Mary Esther resident.

The victim pulled into the parking lot of the Food World at 251 Mary Esther Cut-off around 7 a.m. July 6th to buy groceries. The suspect, identified as Wannamaker by the Okaloosa County Sheriff's Office, approached and asked him to help "jump" the dead battery in his car. The victim agreed to help and took Wannamaker to the nearby McDonald's. Once there, however the suspect said his car had been towed and asked the victim to drive him to his home off Lovejoy Road. On the way, Wannamaker began demanding money. The victim stopped on Dates Avenue and Wannamaker hit the 81-year old man during a struggle over the car keys. Both got out of the car and Wannamaker continued to physically batter the victim before taking off in the victim's car, a tan 2007 Ford Fusion. He then crashed the car into a tree approximately 200 yards away. The victim was taken to Fort Walton Beach Medical Center admitted for treatment of his injuries.

Wannamaker was taken into custody last night (September 21st) without incident after being called in as a suspicious person at the Electric Cowboy in Destin. Okaloosa County deputies and a K-9 unit located and arrested Wannamaker on charges of carjacking, robbery by sudden snatching, aggravated battery on a person 65 or older, leaving the scene of an accident with injuries, and not having a valid driver's license.

Wannamaker is also charged with fraudulent use of a credit card. Investigators say shortly after the carjacking, he used the victim's credit card to buy a \$400 gift card at the Wal-Mart in Fort Walton Beach.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 7/6/11 eighty one year old [redacted], the victim, was approached by John Wannamaker, the defendant, in the parking lot of the Food World located at 251 Mary Esther Cutoff, Mary Esther, Florida. Wannamaker asked [redacted] for assistance. [redacted] agreed to help by giving Wannamaker a ride home. [redacted] then drove to the dead end on Dates Avenue.

During the drive Wannamaker had been asking [redacted] for money. [redacted] refused to give him any. At the dead end of Dates Ave Wannamaker then told [redacted] "I'll kill you" and grabbed the keys out of the ignition. [redacted] attempted to get the keys back from Wannamaker. Wannamaker began to batter [redacted] about his person with a closed fist. [redacted] got out of the vehicle. Wannamaker got out of the vehicle, walked to where [redacted] was and proceeded to physically batter [redacted] again. [redacted] fell to the ground. Wannamaker took the victim's cellular phone and wallet containing credit cards and other personal items.

After doing this Wannamaker got into the drivers seat of [redacted]s tan 2007 Ford Fusion and fled the scene in the stolen vehicle. Wannamaker crashed the vehicle into a tree approximately 200 yards from the area he had battered [redacted]. After crashing, Wannamaker exited the victim's vehicle and fled the scene in a maroon Hyundai.

While on scene [redacted] a witness to the crash, approached and told me "It was J.P. who took the man's car". "J.P." is Wannamaker's nickname. [redacted] told me she watched Wannamaker, who she knows personally, exited

the victim's vehicle, run to a maroon Hyundai, and then flee the scene in the maroon vehicle.

was provided with a photograph lineup with Wannamaker's picture. She immediately identified Wannamaker as being the male she saw leaving the vehicle and the scene. She gave a "110%" confirmed identification.

Later in the day on 7/6/11 I was contacted by a Deputy Matthew Spratt of the Santa Rosa County Sheriff's office. He had completed an informational report in which the victim's wallet had been located at a residence inside his jurisdiction. Also while conducting his investigation Deputy Spratt came into contact with Wannamaker. Brenda McIntyre, the complainant of Deputy Spratt's call, provided Deputy Spratt with the victim's wallet and told him she had found in the chair where Wannamaker had sat in on her front porch. Wannamaker denied knowledge of the wallet but McIntyre states it was not there before he had gotten there and sat down in the chair. Reference SRCO offense number 11-5801 (attached).

Based on the above information I have probable cause to believe John Wannamaker did violate Florida State Statutes 812.133.2b; robbery car jacking without a weapon, 812.131.2b; robbery to a person by sudden snatching, 784.08.2a; aggravated battery on a person 65 years of age or older, 322.03.1; driver must be licensed, and 316.061; leaving the scene of an accident with property damage.
