**MISSISSIPPI AGGRAVATED ASSAULT FUGITIVE ARRESTED BY OCSO
FOR LOCAL STRONG ARM ROBBERY**



Deputies with the Okaloosa County Sheriff's Office who tracked down a suspect in a strong arm robbery Wednesday evening (September 21st) discovered the man is also wanted in Mississippi for aggravated assault with a deadly weapon.

46-year old Henry Lee Easley of West Point Mississippi is charged with robbing a woman as she pumped gas at the AOC Food Mart at 306 Racetrack Road around 7 p.m. last night. The victim says Easley walked up to her, covered her mouth with his hand and demanded her wallet. She gave him cash and her cell phone and he then ordered her to drive away.

Deputies called to the scene set up a perimeter and called in a K-9 unit to help establish a track. They spotted a man matching the description given by the victim riding a bike in the area of Rhonda Kay Court. During a brief chase they saw that individual, later identified as Easley, throw down the victim's cell phone, which was recovered. He also had her cash in his pocket.

Easley was taken to the Okaloosa County Jail. He is also wanted by the Columbus Mississippi Police Department in connection with an aggravated assault with a deadly weapon warrant. Investigators there say Easley repeatedly beat a person with a brick during an altercation on August 16th. The victim survived, but suffered serious head injuries.
