DESTIN BURGLAR CAUGHT IN THE ACT



The Okaloosa County Sheriff's Office has charged a Destin man with burglary after a woman arriving home from work spotted him inside her house.

19-year old Jonathan Charles Berger, no known address, was taken into custody as short time later hiding inside a nearby home.

A Pine Ridge Trace homeowner says she pulled into her driveway around 9 a.m. Tuesday morning to see Berger inside her house. When he spotted her, he ran out a sliding glass door and jumped a fence.

Deputies and a K-9 unit responded to the scene and found Berger sitting inside a living room at a home on Wedge Court.

Investigators are working to determine if Berger is responsible for a second reported burglary on Pine Ridge Trace that was also discovered today.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 09/27/2011 at approximately 0915 hours, I responded to 63 Pine Ridge Trace Destin, FL, in reference to a burglary to an occupied dwelling in progress.

Upon arrival I made contact with victim, Crystal Pirc in the driveway of her residence. Pirc stated she returned home from work and observed the defendant inside her residence. Pirc said once the defendant saw her, he ran out the rear sliding glass door located in the kitchen area. Pirc informed me she observed the defendant jump over the rear fence of 59 Wedge Court Destin, FL and he was hiding inside the residence. Pirc stated she has personally known the defendant for approximately ten years.

The residence located at 59 Wedge Court was surrounded by additional deputies were the defendant was located sitting in the living room. I drove past 59 Wedge Court with Pirc inside my marked patrol vehicle and she positively identified the suspect she observed inside her residence. Pirc further stated the defendant was never given permission to enter her residence.

Post Miranda, the defendant requested an attorney and all interviews ceased.

I do believe the defendant did commit the offense of Burglary to an Occupied Dwelling per F.S.S. 810.02(3). This offense occurred in Okaloosa County on 09/27/2011 were your affiant is a sworn law enforcement officer.
