## **BAKER TEENS CHARGED WITH SHOOTING AT DEER IN FRONT YARD**

The Okaloosa County Sheriff's Office has arrested two Baker teenagers on charges they shot at a deer in someone's front yard on September 4<sup>th</sup>. 16-year old Christopher Kyle Pennington and 17-year old Jacob Paul Campbell are charged with firing a weapon from a vehicle, a second degree felony.

The victim says two white males on a Red Honda ATV used a spot light in his front yard around 8:45 p.m. and then fired a weapon twice at a deer in the yard.

Sheriff's Deputies tracked ATV tire tracks from the man's house at 5905 Dairy Road in Baker to a home at 6039 Dairy Road. They found a red Honda ATV with the engine still warm, fresh mud on the tires, and a shell casing on the seat. They talked to both teens and say Campbell admitted they had been riding and shooting most of the day, with Campbell as the passenger and Pennington as the driver. They denied being on Dairy Road at night.

Deputies seized a Savage model 93 R17 as evidence. They say the shell casing that was on the ATV was fired from an R17.

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On September 4, 2011 I responded to 5905 Dairy Road, Baker for a shots fire call. I made contact with Tyler Tobias who stated two white males on a Red Honda ATV(Rancher) shined a spot light in his yard and fired a weapon twice from Dairy Road. Tobias stated they were firing at a deer that was in his front yard. He yelled at them and they departed going North on Dairy Road. He further stated he followed them in his vehicle until they turned onto private property. He provided this officer with directions to where he saw them enter private property.

Deputy Corbin and I followed the ATV tire tracks and located the Red Honda Rancher ATV parked at 6039 Dairy Road, the engine was still warm, fresh mud on the tires and one shell casing on the seat. The property belongs to Victor Campbell, he was advised as to why we were there. This officer inquired who was riding the Red Honda ATV. Campbell had two juveniles Jacob Campbell and Kyle Pennington come out of his residence. J. Campbell stated they had been riding and shooting most of the day but denied being on Dairy Road at night. I inquired who was driving and Pennington stated he was driving and Campbell was the passenger. A Savage model 93 R17 was seized as evidence. The casing that was located on the ATV was fired from a R17.

Based on the victims sworn affidavit and corroborating physical evidence, I have reason to believe that Jacob Campbell violated Florida Statute, 790.15(2) Discharging a Firearm in Public from a Moving Vehicle. This offense occurred in Okaloosa County, Florida where I am a sworn law enforcement officer


[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]


