CRESTVIEW TEEN FACES MULTIPLE SEXUAL BATTERY CHARGES

The Okaloosa County Sheriff's Office has arrested a Crestview teen on multiple charges connected to the sexual molestation of six separate victims.

16-year old Matthew Quentin Mclean of Crestview was arrested on September 2nd. The charges include sexual battery on a victim under 12, lewd and lascivious molestation, and lewd and lascivious battery. The incidents occurred at various locations in North Okaloosa County over a period of time ranging from January 2008 to January 2011.

Investigators say the victims ranged in age from four to fifteen.

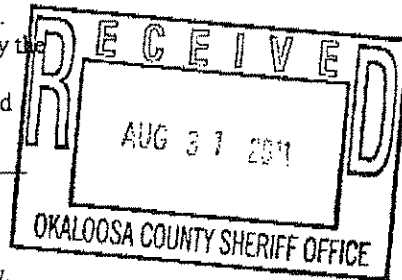

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

Based on a Florida Intake Report, a forensic interview, and sworn witness statements from witnesses stating to wit:

On or about the month of May of 2010, the victim _____, 11 years of age was living with her family at Okaloosa County, Florida. The defendant/ _____ Matthew

McLean, 15 years of age,
 On an unknown exact time on or about the month of May, the defendant McLean went into the victim's bedroom and put his hand up the leg of her pants, fondling/rubbing her vaginal area, skin to skin. McLean did this to the victim approximately four times and each time he did it, the victim would be lying in her bed. Approximately two of these times, McLean used his hand and fondled/rubbed the victim's vaginal area on the outside of her clothing. When McLean would fondle the victim, she would tell him to stop and he would refuse to do so. McLean further would tell the victim not to tell anyone.

On April 18, 2011 during a non-custodial interview. McLean denied any sexual contact between him and the victim and advised he would never do anything.

I have reason to believe and do believe that Matthew McLean did violate Florida Statute 800.04(5c1); Lewd or Lascivious Molestation in Okaloosa County, Florida.

After shutting the door, McLean engaged in sexual intercourse with the victim.

On one occasion during the month of December, the victim was in the shed type building, sitting on the couch with McLean and he began telling her to touch and play with his penis. [STATEMENT OF PROBABLE CAUSE / NARRATIVE]

Based on a Florida Intake Report, a forensic interview, and sworn witness statements from witnesses stating to wit:

On or about the months of December 2008 through January 2009, the victim, 13 years of age, was visiting Holt, Okaloosa County, Florida. The victim was in a room drawing and the defendant, Matthew McLean, 13 years of age, came into the room and started rubbing/fondling her vaginal area with his hand over her clothing. McLean did this at least five times and the victim kept pushing him away. McLean also told her not to tell anyone.

Further, on or about January of 2011 at an unknown exact time, the victim, 15 years of age, was riding in the back seat of a vehicle in the area of Holt, Florida. McLean, 15 years of age, was also in the back seat with her. McLean put his hand into the front of the victim's pants and inserted one of his fingers into her vagina. The victim attempted to stop him but McLean pushed her back into the seat and forced his hand down her pants. As he was doing this, McLean would rub his hand down the victim's chest area, fondling her breast, and then continue to put his hand into her pants.
