OCSO MAKES ARREST IN PHONE CABLE THEFT



A Baker man is charged with dealing in stolen property in connection with the theft of utility phone cable in the Baker area. 30-year old Jason Wayne Stringer of 5392 Dodson Road was arrested on multiple counts.

Century Link Phone Company had reported three incidents of stolen wiring during January in rural areas of Baker. Approximately 300 feet of wiring was taken from near Shockley Springs and Old River Roads, leaving nine customers without service and costing up to \$18,000 to repair. In another theft, cable worth up to \$20,000 was taken from phone poles on Highway 189 North. In addition, someone cut cable off phone poles along John Riley Barnhill Road, leaving twelve customers without service, and costing close to \$5000 to fix.

Okaloosa Sheriff's investigators developed information and executed a search warrant January 12th at 6980 Eadie Cotton Road in Baker. They found Century Link phone cable. Another search warrant was executed six days later at 1473 Vinson Ray Road. Stringer arrived and admitted taking cable from two locations. When arrested on OCSO warrants February 20th, Stringer had a baggy in his front pocket containing methamphetamine. He was also charged with possession of a controlled substance.

The investigation is ongoing and additional arrests are expected.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 1/18/12 at approximately 2200 hours, the Okaloosa County Sheriff's Office was conducting an investigation at a residence in Baker, Florida. Information was received that narcotics equipment was located in a shed belonging to Jason Wayne Stringer. Jason Wayne Stringer consented to a search of his shed in his back yard at 1449 Vinson Ray Road, Baker, Florida.

During the consensual search of the shed, a marijuana smoking pipe and a small baggy of suspected marijuana were discovered in plain view. A more detailed search of the shed revealed a small baggy of suspected methamphetamine and a glass meth pipe in a hidden compartment along with a letter addressed to Jason Wayne Stringer. When I opened the hidden compartment Jason Wayne Stringer stated, "man, you found my cubbyhole."

Post-Miranda, Stringer advised the marijuana and marijuana pipe were his. He stated the letter in the hidden

compartment was his as well, but the methamphetamine and meth pipe were there without his knowledge. Stringer freely admitted he uses methamphetamine and readily identified the meth pipe as such.

A presumptive field test of the marijuana yielded a positive response for the presence of THC. A presumptive field test of the methamphetamine and meth pipe yielded a positive response for the presence of methamphetamine.

Based upon the aforementioned information, I have reason to believe and do believe that Jason Wayne Stringer violated F.S.S.893.13(6a) Possession of a Controlled Substance to wit: methamphetamine, F.S.S.893.13(6b) Possession of Marijuana less than 20 grams, and F.S.S.893.147(1b) Possession of Paraphernalia.

This incident occurred in Okaloosa County Florida where I am sworn law enforcement officer.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

Based on a sworn Affidavit of Complaint signed by Century Link Phone Company Representative Mike Decker along with a criminal investigation stating to wit:

On January 5, 2012, Century Link employees in the area of Peaden Bridge Road and Eadie Cotton Road reported to the Okaloosa County Sheriff Office that person(s) unknown were stealing utility phone cable around the area of Peaden Bridge, which is located near the intersection of Peaden Bridge Road and Eadie Cotton Road. A Sheriff's Office camera was installed in the area in hopes of obtaining surveillance photos of the suspects. The camera was mounted on a tree approximately 15 feet off the ground with phone cable left near the camera as bait. On January 6, 2012 at approximately 0815 hrs, the camera was checked and was still in place. On January 9, 2012 at approximately 1550 hrs, the camera was checked and discovered missing/stolen.

Over the past few weeks Century Link Phone Company reported (3) incidents of aerial copper telephone cable stolen in and around the rural portion of the Baker Community. The first incident was near the intersection of Shockley Springs Road and Old River Road, during which approximately 300 feet of phone cable was stolen and left approximately nine customers without telephone service. The cost of repair is estimated near \$15,000-\$18,000, counting labor and cost of material. The second incident was on HWY 189 North, during which phone cable valued at approximately \$20,000, was cut from telephone poles. The most recent incident was on John Riley Barnhill Road, during which 50 pair cable was cut

going up the telephone poles at both ends of Peaden Bridge that left 12 customers without service. The cost of repair was estimated between \$4-\$5000.

On January 12, 2012, a search warrant was executed for the premises located at 6980 Eadie Cotton Rd., Baker, FL, which belongs to Joe McCombs and Barbara Sue Ganey. While serving the search warrant, Century Link phone cable was located at the said residence. Information was also obtained about Jason Wayne Stringer stealing phone cable and possessing a stolen Sheriff's Office surveillance camera. Jason Stringer and Joe McCombs used to scrap together but have since started scrapping alone. Jason Stringer took the camera and apparently downloaded pictures that the camera captured which depicted Barbara Sue Ganey and Joe McCombs stealing the baited phone cable.

A check with Southern Recycling located at 5155 Ellis Rd., Milligan, FL revealed that Jason Stringer and Melissa Stephens have been selling an abundance of copper wiring. A photo of the copper that the business received from Stringer and Stephens was small diameter size wire, which coincides with the phone cable that was recently stolen.

On January 18, 2012, Jim Ward, Judge, Circuit Court of the First Judicial Circuit approved and issued a search warrant based on the previously mentioned facts, for the premises located at 1473 Vinson Ray Road. While serving the search warrant, Jason Stringer arrived at the residence and provided the stolen Sheriff's Office surveillance camera (with OCSO written in black permanent marker on the back of the camera). The memory stick and batteries were missing from the camera. While on scene, I conducted a non-custodial interview with Jason Wayne Stringer, which admitted to taking phone cable from century link Phone Company at two different locations. Jason Stringer also pointed out copper that was recently stripped of the insulation which came from Century Link Phone Company. Per Stringer, he took phone cable from John Riley Barnhill Road and Shockley Springs Road. Stringer further stated that he would search the two areas and noticed phone cable protruding from the ground. He would then pull the phone cable up and take what he could. Based on the aforesaid information, I have reason to believe that Jason Wayne Stringer did commit the offenses of Theft of Copper or Other Nonferrous Metals from a Communications Provider and Dealing in Stolen Property to wit: intentionally stealing century link phone cable from the area of Highway 189 N. with intent of melting the insulation off the stolen wire and selling same for monetary gain. These offenses violate Florida State statutes 812.145 / 812.019.1 and did occur in Okaloosa County.


