

TRAFFIC INFRACTION CIVIL PENALTIES

**** Effective 12/15/2011 ****

PEDESTRIAN / BICYCLE VIOLATIONS

\$ 61.50 Examples: F. S. 316.130-Pedestrian violation, 316.151(1)(c) - Bicycle Improper turn
APPLIES ONLY TO OFFENDERS 14 YEARS OLD OR YOUNGER - 15 AND OVER = SAME CIVIL PENALTY AS OPERATING MOTOR VEHICLE

NON-MOVING VIOLATIONS

\$ 113.00 Examples: FS 316.614-Seat Belt Viol., 322.065-Expired D/L < 4 mos.
\$ 183.00 Violation of FS 316.1955 or 316.1956 - Handicapped Parking

MOVING VIOLATIONS (NON-SPEEDING)

\$ 163.00 F.S. 316.1925-Careless; **316.123(2)(A)**-Ran Stop Sign; **316.1001**-Fail Pay Toll **\$206.00 (one axle)(6/1/10)**
\$ 268.00 F.S. 316.172(1)(a)-Fail Stop for School Bus **316.172(1)(b) Passing Enter/Exit Side=Mand Court**
\$ 261.00 F.S. 316.075(1)(c)1- Fail to Obey Traffic Control Signal Devices
 F.S 316.2085(2) -Improper Riding; (Astride or Motorcycle/Moped wheels losing contact with ground)
 F.S. 316.2085(3) -Motorcycle/moped tag improperly affixed
 \$1,163.00 (First Offense) \$2,663.00 (Second Offense)
316.074(1)- Failure to Obey TCD- Sign \$163.00; Light \$261.00

SPEEDING VIOLATIONS

Violations of F. S. 316.1926 (2) Speed in excess of 50 MPH or more in violation of F.S. 316.183(2); 316.187 (state speed zones), or 316.189 (municipal & county speeds) is a *Mandatory Court Date* 4 POINTS

MOVING VIOLATIONS (NON-SPEEDING) – 3 points

**Violations of F. S. 316.2085 (2) Motorcycle or moped, wheels losing contact with ground;
Violations of F. S. 316.2085 (3) Motorcycle or moped license tag improperly affixed:**

\$ 1,163.00 Total Civil Penalty - First Offense
\$ 2,663.00 Total Civil Penalty - Second Offense

MOVING VIOLATIONS (SPEEDING) – 4 points **INFRACTION WITH MANDATORY COURT**

****Violations of F. S. 316.1926 (2) Speed in excess of 50 MPH or more in violation
of F.S. 316.183(2) (posted speeds); 316.187 (state speed zones), or 316.189
(municipal & county speeds).**

\$ 1,103.00 Total Civil Penalty – First Offense Min Mandatory Civil Penalty to be Imposed by Judge
\$ 2,603.00 Total Civil Penalty – Second Offense- Min Mandatory Civil Penalty to be Imposed by Judge

**** The F.S. 316.1926(2) must be used in order for the enhanced penalty to be applicable.
If it is not used, the citation will be treated as the 30 over speed limit citations are, infraction with
mandatory court appearance.**
