Employee. The tip reported the parties were involved in a sexual relationship.

I made contact with the victim at the abovementioned residence. He denied having a sexual relationship with the defendant and gave me consent to search his phone. I observed a photograph in the victim's photo gallery displaying both parties kissing. I confronted the defendant about this photograph and he continued to deny having any type of sexual relationship with the defendant.

During a sworn non custodial interview with the defendant and she admitted to having sexual intercourse with the victim approximately 7 to 8 times at the abovementioned location and at her previous residence located at 1508 Kruse Dr, Fort Walton Beach, FL. The defendant stated she knew it was wrong and allowed the sexual relationship to continue. The defendant also told the victim that what they were doing was illegal and the defendant was aware the victim was seventeen years old.

After the defendant was arrested, the victim then admitted to having sexual intercourse with the victim and did not believe it was wrong because he was not being "raped" and was "about to be 18".

Based on the above investigation, I believe the defendant violated Florida State Statutes, F.S.S 794.011 (8b) Sexual battery by custodian (victim under 18 yoa). These offenses occurred in Okaloosa County, FL, where your affiant is a sworn law enforcement officer.
