CASE NUMBER 09-1028DEFENDANT Nafi, Muta Ali AADDENDUM OF PROBABLE CAUSE

On January 28, 2009, Muta Ali A Nafi entered the business of Cash's Liquor located at 767 Harbor Blvd, Destin, Florida. Nafi pulled out a handgun, placed the muzzle of the gun against the left side of the clerk's body and demanded all of the money from the register and a separate change box. The total amount taken from the business was \$794. Nafi fled from the business on foot but was pursued by the business owner William Moore.

During this pursuit, William Moore, stopped on the side of the road of 98 Palms Drive, which is about a half mile away from the business, called 911 to report he believed he was stopped behind Nafi's escape vehicle, which was a black Chrysler four door. Nafi walked from the shadows behind Moore's vehicle, walked around to the driver's side of Moore's vehicle about 10 feet away and fired his handgun at the driver's side door. The driver's side window to Moore's vehicle shattered and the bullet lodged into the upper frame of the door, at about head level. Moore did not observe Nafi approach his vehicle. Moore sustained only minor lacerations to the face from the shattered glass. This incident was witnessed by Kayla Linnette Warden, who was about 30 feet away in the vehicle in front of Moore's.

Nafi then got into the passenger side of the vehicle Warden was driving, which is a black Chrysler four door and ordered her to drive. Moore continued to follow the vehicle where he observed it go into the Twin Lakes Subdivision off of Airport Road in Destin, FL. Moore stopped on Airport Road and did not enter the subdivision and reported his location to 911. Okaloosa County Sheriff's Office deputies entered into the Twin Lakes Subdivision attempting to locate Nafi when a white Dodge truck bearing Florida license M795KR erratically and quickly drove off leaving the subdivision. The vehicle failed to stop at stop signs and as it approached Airport Rd, Moore recognized the passenger female as the same female who was the driver of the black Chrysler. Marked patrol vehicles with their emergency lights and sirens activated pursued the white truck which Nafi was driving in an attempt to stop the vehicle. During the pursuit Nafi drove at high speeds, ran stop signs/lights which was a willfull and wanton disregarded manner for the safety of other persons and property.

I do believe Muta Ali A Nafi committed the offense of Robbery while using a firearm and during the course of this robbery, deprived the business of \$794. This is a violation of Florida State Statute 812.13(2)(a) which did occur in Okaloosa County Florida.

I do believe Muta Ali A Nafi committed the offense of Attempted Murder by willfully shooting into the driver's side window of Moore's vehicle from close range with the intent to seriously injure or kill the driver of the vehicle, which is Moore. The attempted murder was in perpetration of the armed robbery which had just occurred where Moore was in between Nafi and his escape vehicle. This is a violation of Florida State Statute 782.04(3) which did occur in Okaloosa County Florida.

I do believe Muta Ali A Nafi committed the offense of Fleeing and Eluding Law Enforcement by failing to stop while being pursued by marked patrol cars from Okaloosa County Sheriff's Office, while their emergency lights and sirens were activated and did so in a willful and wanton disregarded manner for the safety and welfare of other persons and property. This is a violation of Florida State Statute 316.1935(3)(a) which did occur in Okaloosa County Florida.

A criminal history check of Muta Ali A Nafi revealed he has a prior name and alias of Steven Pressley where he has been convicted by the State of South Carolina Courts as a convicted Felon on October 11, 1984. I believe Muta Ali A Nafi is a convicted felon and was in possession of a firearm and used the firearm in the robbery and attempted murder. This is a violation of Florida State Statute 790.23(1)(e) which did occur in Okaloosa County Florida.

The basis for this Probable Cause is founded in the investigation of a Home Invasion Robbery, False Imprisonment, and Grand Theft. The incident occurred on January 28th, 2009. at approximately 7:30 p.m., at 2003 Cord Grass Court in Destin, Florida.


The Victim, Tammy Leger Courville, completed a sworn affidavit of complaint. The Victim stated she was at her residence located at 2003 Cord Grass Court, when she heard someone at the front door. She opened the front door and found an unidentified female standing there. The female asked her for help because she had gotten a vehicle stuck in a nearby sandy area. The Victim recalled hearing the female, later identified as Kayla Linnette Warden, saying could she help "us." indicating she was with someone else. The Victim was going to let Warden use her cellular phone and as she turned back around to Warden, an unidentified male entered her residence. The male, later identified as Muta Ali A Nafi, brandished a firearm and pointed it at the Victim. Nafi then demanded the Victim's car keys. The Victim followed Nafi and Warden outside the front door and relinquished her keys. Nafi then demanded the Victim to enter her own vehicle and sit in the middle seat. The Victim's vehicle was described as a white, 1991 Dodge pickup truck with Florida plate number M795KR. (VIN # 1B7GE16Y2MS218597) Nafi got into the driver's seat and Warden got into the passenger seat. Nafi then drove away from the Victim's residence in the Victim's truck without her permission. As Nafi proceeded to exit the residential area, Okaloosa County deputies began to pursue the Dodge truck. The deputies had already been in the vicinity investigating another crime scene relating to an armed robbery and attempted murder. (OCSO case # 09-1028) These two incidents were soon realized to contain the same suspects.

Nafi did not submit to law enforcement and a pursuit ensued. The pursuit resulted in the apprehension of Nafi and Warden. It also resulted in the safe recovery of the victim. The recovery of the truck also produced the firearm described by the Victim as having been pointed at her. The firearm was listed as a Smith & Wesson brand, SW9VE model, 9mm, pistol. (Serial # PBV3587)

In a post-Miranda statement, Warden stated she witnessed Nafi enter and flee the related armed robbery scene, shoot an occupied vehicle, and drove Nafi away only to get their original vehicle stuck and rendering it disabled. She went on to state she chose the Victim's house to get help, in order to further their escape. She offered no aide or assistance to the Victim when the Victim was confronted by the firearm toting Nafi. She also accompanied Nafi inside the Victim's truck as Nafi attempted to flee the entire area to avoid both crime scenes.

Based on the investigation, I have reason to believe and do believe, the Defendant, Muta Ali A Nafi, did commit the offenses of Home Invasion Robbery False Imprisonment and Grand Theft, in violation of Florida Statutes 812.135 (2a) 787.02 (1a), 812.014 (2c6)

The offenses occurred in Okaloosa County, where your Affiant is a sworn law enforcement officer
