RELEASED INMATE BURGLARIZES CARS IN JAIL PARKING LOT



A Crestview man released from the Okaloosa County Jail on a domestic violence battery charge Wednesday didn't even make it out of the parking lot before committing crimes which put him right back in a cell.

38-year old Gabriel Allen Kirkpatrick of Grady Lane in Crestview is charged with four counts of burglary.

Kirkpatrick had just been released March 14th when Okaloosa Sheriff's deputies say he went into the jail parking lot and started trying to break into cars. In one case, he unscrewed the radio antenna from the exterior and was trying to use it to gain entry.

Kirkpatrick was placed into custody and taken back inside for processing.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On March 14, 2012, at 2138 hours, I responded to 1200 E. James Lee Blvd. in reference to a vehicle burglary complaint in which the defendant, Gabriel Kirkpatrick, had attempted to gain unauthorized entry into four vehicles after just being released from incarceration from the Jail.

I made contact with victim #1, LeRoy Huygues, who stated at 2130 hours, he was asked to come outside to assist with clearing an individual from the parking lot. While he was outside he observed the defendant attempting to "pop" (forcibly open) the lock to his 1999, Chevrolet Camaro, bearing FL tag# L602F. Huygues further stated when he and other officers went to detain the defendant he discovered that the defendant had unscrewed the radio antenna from the exterior of the vehicle, and that was how he was attempting to gain entry into the vehicle.

Contact was then made with victim #2, Patrick Hanratty who stated he was advised the defendant had attempted to break into victim #1 vehicle. When he made contact with the defendant and asked him why he was attempted to burglarize that vehicle, the defendant told him that he was mad because he just attempted to break into a 2012, Dodge Charger, bearing FL Tag# L000BE, but was unsuccessful. The aforementioned vehicle was the property of victim #2.

Contact was then made with victim #3, Charles Nabers, who advised that he was informed that the defendant tried to gain entry into his 2004, Ford F-150, bearing FL Tag#G572KL. Victim #3 further stated no damage was done he just noticed several fingerprints around the door handle and window, which weren't there when he arrived for work.

Contact was made with victim #4, Megan Huggins, who stated she was outside smoking a cigarette when she observed the defendant trying to open the door to a Dodge Charger and a Ford F-150, which were parked next to each other. She further stated when he failed to gain entry into those vehicles, he approached her vehicle, 2005, Chevrolet Impala, bearing FL tag# ASH9673, and attempted to gain entry into it. Victim #4 further stated she yelled "thats my vehicle," and upon doing so he quickly ran east through the parking lot, and that as she approached her vehicle that was when she observed the defendant attempting to gain access to Victims #1's Chevrolet Camaro on the far east side of the parking lot.

Contact was then made with witness #1, Melissa Roper, witness #2, Lawrence McKean, and witness #3, Aaron Broxson, who all observed the defendant attempting to gain entry into victim #1 vehicle. They also stated prior to my arrival the defendant verbally stated he had attempted to gain entry into all the aforementioned vehicles.

Contact was then made with the defendant; post Miranda, he stated he had attempted to gain access to all four vehicles, however, he stated he thought the Chevy Camaro was left for his use by his friend.

Based on the aforementioned information, I have reason to believe and do believe the defendant Gabriel Kirkpatrick violated F.S.S. 810.02.4b Burglary to Conveyance; to wit the defendant attempted unlawful entry into four vehicles to commit offenses therein. These offenses occurred in Okaloosa County, Florida where I am a sworn law enforcement officer.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On March 12th, 2012, I responded to a family disturbance already occurred at 119 Eagle Court, Crestview, Florida.

Summer Kirkpatrick informed me in a verbal interview and sworn written statement that the defendant, Gabriel Kirkpatrick, had been in an argument with several family members, including herself, at 3478 Grady Lane, Crestview, Florida around 2000 hours. During this argument, Gabriel grabbed Summer by her arms and pushed her away.

Summer and Gabriel are married and have children together. They have been married for 14 years.

Elizabeth Seiber and Stephen Seiber both witnessed this event. They informed me in verbal and written statements that they observed Gabriel pushing Summer.

Gabriel informed me in a verbal interview, post Miranda, that he had been in an argument with several family members in his house. During this argument, he pushed his wife away because she was standing in a doorway that he wanted to walk through.

This is a violation of F.S.S. 784.03(1a1), Battery (Domestic Violence.) This offense occurred in Okaloosa County, Florida.
