OCSO CAPTURES SUSPECTED PURSE-SNATCHING CAR THIEF



Okaloosa Sheriff's deputies responding to a call of a suspicious person in a Wal-Mart parking lot Sunday say the suspect turned out to be the same person they believe stole a purse and then a car from an elderly Wal-Mart shopper on March 29th.

The 82-year old victim from the March 29th incident says someone took her purse containing her car keys, wallet, and cash from her shopping cart while she was inside the Wal-Mart on Beal Parkway. When she left the store, she found her 1998 Nissan Maxima was missing.

OCSO Communications received a call yesterday of a suspicious person in the parking lot of the same Wal-Mart. The car the man was operating was the one stolen from the shopper two days earlier.

60-year old Luis Antonio Eloy is now charged with grand theft of a motor vehicle and theft.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 03/29/13 the Okaloosa County Sheriff's Office responded to a report of a theft which occurred at 748 N. Beal Parkway, Fort Walton Beach. The victim, 82 year old Betty Conley, reported that her purse, containing car keys, wallet, and \$50 U.S. currency had been taken from her shopping cart while she was unaware. Conley's wallet and purse were later recovered but upon exiting the store she discovered her vehicle, a 1998 Nissan Maxima bearing FL tag A637QP, had also been taken from the parking lot. Wal-Mart video surveillance captured the suspect and his actions. The suspect was described as a dark skin white male (possibly Latino) wearing blue knee length shorts, and green military style boots.

On 03/31/13 OCSO Communications received a call of a suspicious person in the parking lot of the same Wal-Mart, Fort Walton Beach. The vehicle this reported suspicious person was said to be operating was described as the same Nissan Maxima which had been stolen from Ms. Conley two days prior.

The suspicious person, later identified as the defendant Luis Antonio Eloy, was located outside and beside the stolen

hicle and detained. Eloy is a Latino male and was wearing the same blue shorts and green military style boots as could
observed in the Wal-Mart surveillance video.

In a post-Miranda admission, Eloy admitted to taking the vehicle although he stated he did not know who the owner was. According to Eloy he found the vehicle in the parking lot of Wal-Mart with the keys in it, and subsequently took it. Eloy stated he has been driving it as if it were his own for the last two days.

Based on the above probable cause the affiant has reason to believe and does believe that the defendant, Luis Antonio Eloy, has committed the offenses of Theft and Grand Theft (motor vehicle). These offenses are in violation of Florida

State Satutes 812.014(1)(a) and 812.014(2)(c)(6) respectively and occurred in Okaloosa County, FL.
