<u>DEPUTIES NAB DRIVER WHO RAMMED PHARMACY WITH</u> <u>TRUCK IN BURGLARY ATTEMPT</u>



Surveillance video and an alert deputy led to the arrest early this morning of a burglary suspect who tried to ram his pick-up truck through the doors of a Baker pharmacy.

The Okaloosa County Sheriff's Office has charged 31-year old Jonathan Ersel Mullins, no known address, with burglary, possession of burglary tools, and resisting arrest without violence.

A deputy was called to Health Smart Pharmacy on Highway 189 in Baker when an alarm went off around 1:23 a.m. this morning. A review of the business's surveillance video showed a man first trying to get in through a window, and then by using his Chevrolet Z-71 King Cab pick-up truck filled with items to ram the glass front doors. The building suffered major damage.

A short time later, the deputy alerted fellow officers after hearing a call being dispatched for a possible intoxicated driver on Highway 90 driving a white pick-up truck filled with items. The truck was located in the driveway at 657 Brunson Street. When the deputy arrived, he was able to identify it as the same truck used to ram the pharmacy. He also identified Mullins, lying down in the front seat, as the man in the surveillance video. Mullins was tased after reaching into the backseat while refusing commands to get out of the truck, then fighting while attempts were made to handcuff him.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 08/06/2013, at or about 1:23 am, the defendant Jonathan Mullins attempted to gain entry into the HealthSmart Pharmacy, a closed business, located at of 5809 HWY 189, Baker, FL. Mullins attempted to enter the business via two different locations, to wit: through a window which housed a "window unit" air conditioner which is located on the rear of the business, and by striking the front of the business with his vehicle. Mullins used a common kitchen knife to cut away weather stripping from the air conditioner which was located on the rear of the business and hidden from view from the street and adjoining properties. The knife was located at the scene. Additionally, Mullins backed his Chevrolet Z-71 pick-up into the front of the business, striking the wall near the front glass doors, in an attempt to break the glass in the front doors. Mullins' attempts to enter the business caused major damage to the building and were captured and recorded on video surveillance security cameras.

Mullins and his vehicle were located a short time after th	e attempted break-in at an unoccupied residence and he and the
vehicle were positively identified from the video surveilla	nce. When Mullins was contacted, he resisted extrication from
the vehicle, actively fighting with deputies until tasers we	ere deployed in order to take him into custody. Inside his vehicle,
Mullins also was in possession of a large pry bar.	

These incidents occurred in Okaloosa County, Florida where I am a sworn law enforcement officer. Based on the above information, I have just and reasonable grounds to believe, and do believe, the defendant, Johnathan Mullins committed the offense of Burglary, Possession of Burglary Tools, and Resisting an Officer Without Violence in violation of F.S.S. 810.02, F.S.S. 810.06, F.S.S. 843.02, respectively, and the actions of the defendant are contrary to the peace and dignity of
