CRESTVIEW HIT & RUN DRIVER CHARGED WITH AGGRAVATED BATTERY WITH DEADLY WEAPON



The Okaloosa County Sheriff's Office has charged a hit and run driver with aggravated battery with a deadly weapon after learning she deliberately struck another woman with her car this morning in Crestview.

27-year old Heather Marie Heitger of 1649 James Lee Boulevard is accused of deliberately driving her car into 20-year old Melissa Bailey near the intersection of 3rd Avenue and Ferdon Boulevard around 8:30 a.m.

Witnesses say the pair appeared to be arguing before Heitger's black Dodge Durango accelerated rapidly and hit Bailey, propelling her into a nearby gutter.

Bailey suffered serious injuries and was taken to North Okaloosa Medical Center before being later transferred to Sacred Heart Hospital in Pensacola. She was last listed in critical condition.

Okaloosa deputies located Heitger's car in an alleyway with several items placed in front of it as if to conceal it. They tracked down Heitger, who told them she accidentally struck Bailey. Deputies however gathered information indicating Heitger and Bailey may have been involved in a dispute over some Facebook messages.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On August 7th, 2013, Charles Havens witnessed a black Dodge Durango strike a pedestrian, and then drive off. In a verbal interview and sworn written statement, he described this vehicle parked in the intersection of 3rd Avenue and Ferdon Boulevard, facing the stop sign. The driver of this Durango was in a verbal argument with a woman on the crosswalk, in front of the Durango. He witnessed this vehicle accelerate rapidly, striking the victim with the passenger side of the vehicle and throwing her into the gutter.

This incident was also witnessed by Rita Tate. Rita advised in a verbal interview and sworn written statement that she was across of Highway 85, waiting to pull into traffic, when she saw a woman talking and pointing at a person in a black truck. She observed this vehicle accelerate rapidly and striking the woman, causing her to hit the ground.

The victim of this offense was later identified as Melissa Bailey. When I arrived, I observed that Bailey was lying on the shoulder of the road, near the curb at the south end of the intersection. She was lying along a northwest to southeast axis, with her feet pointing northwest and her head pointing southeast. She had a large amount of blood on her body which appeared to be from a wound on her head. After she was transported to the North Okaloosa Medical Center,

it was discovered that Melissa had scratch marks along her back, several scratches on her right ankle, and a bleeding wound on the back of her head, approximately 1 1/2 inch wide. The impact on her head caused bleeding in her brain, and she was transferred to Sacred Heart in Pensacola via helicopter.

The vehicle was later found hidden in an alleyway to the south of 1649 E James Lee Boulevard, Lot 5, Crestview, Florida. It should be noted that this area is not easily visible from the driveway of the mobile home park, and there were several items placed in front of it, as if to conceal the vehicle. The back end of this vehicle was parked towards the trailer, blocking view of the license plate.

The driver was later identified as Heather Heitger. Post Miranda, Heitger originally denied any involvement in the offense. After being confronted with the information about the scene, Heitger claimed that she would "black out" when she was angry and would forget what would happen over large periods of time. Eventually, she admitted that she had been in an argument with her boyfriend, Thomas, while she was driving. This caused her to get upset, and she ended up getting into an argument with a pedestrian crossing the street for a reason that she could not remember. She noted that she did not know who this woman was. After the argument, she went to drive away to the doctor's office. She believed that this woman had cleared her car; however, she did not and she accidentally struck her. She was afraid to call for help, believing that her kids would be taken away. She also provided me with a sworn written statement.

There was also a passenger, identified as Thomas Robinson. In a verbal interview and sworn written statement, Thomas stated that he had been in the Durango with Heather. As they were going southbound on Highway 85, she saw a woman walking alongside the road. Heather turned around in a nearby car wash, and then got into an argument with the woman. She went to go pull into traffic, and as she did, she ended up striking the woman. Afterwards, he told her that she needed to stop and entered into an argument with her.

Carri Thomas lives with Heather Heitger. According to Carri, she had seen Heather driving the vehicle during the day. Just prior to Heather's arrest, she observed Heather pull the vehicle into the back alleyway, where Heather told her that she needed to wash the car. Carri also verified that Heather knows who Melissa is, and that Heather had threatened to "beat Melissa's Bailey's butt" in the past over Facebook messages. She also noted that Melissa Bailey also goes by the name of "Missy."

It should be noted that during my interview, Heather told me that she was having an ongoing dispute with a woman named "Missy Gray." Checking MNI, I found that Melissa is known to be in a relationship with a man named Bobby Gray Jr. Due to Melissa's relationship with Bobby, and the fact that she goes by the name of "Missy," it is very likely that she was referring to Melissa Bailey.

This is a violation of F.S.S. 784.045, Aggravated Battery. This case occurred in Okaloosa County, Florida.
