

CRESTVIEW MAN FACING CHARGES OF CHILD MOLESTATION



The Okaloosa County Sheriff's Office has charged a Crestview man with lewd or lascivious molestation of two female victims under the age of 16 and attempting to molest a third.

Deputies arrested 58-year old Donald Vernon Kelley of 3535 Woodcliff Drive Friday evening (December 19th).

During the course of the investigation, they found evidence Kelley had touched or fondled two girls under the age of sixteen, and given at least one of the victims alcohol and marijuana. He is also accused of attempting to fondle a third young girl. In addition, investigators found Kelley had violated an injunction for protection.

Kelley is charged with three counts of contributing the delinquency of a minor, five counts of interfering with the custody of a minor, two counts of lewd or lascivious molestation of a child, one count of attempted lewd or lascivious molestation, and possession of a firearm by a convicted felon.

Investigators say there could be other victims in the local area and ask anyone with additional information to contact OCSO Investigator Ralph Garrett at 850-689-5659.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE] Based on a sworn affidavit of complaint, forensic interviews, and sworn statements from witnesses stating the following: victims met the defendant, Donald Kelley, on or about 2009 while they were living in Crestview, Florida, Okaloosa County. Shortly after meeting the children, Kelley began purchasing gifts and clothing for the them. On or about December 24, 2011, an allegation was made that Kelley was being inappropriate, in a sexual manner, with some of the children, at which time told Kelley to leave her children alone and stay away from Kelley then began having the children go to one of their neighbor's residence who lived near the children. He would pick them up and take them to his residence at 3535 Woodcliff Drive in Crestview, Florida, Okaloosa County; or have the would allow them to swim in his swimming pool. Kelley introduced himself to ____as being the children's grandfather. Kelley would also let the girls spend the night at his residence, and sometimes the boys. He would have the children tell their mother they were spending the night with friends. Kelley continued to purchase gifts for the children, such as keyboards, guitars, Kindle Fire's, clothing, computers, bicycles and other items. ////told Kelley on several different occasions to leave her children alone and stay away from them, and Kelley refused to listen to her. ____filed an Injunction for Protection against Kelley in November of 2012 and during the hearing Judge Ketchel refused to grant the Injunction, but did warn Kelley to leave the children alone because it could lead to his arrest. After the hearing, Kelley continued with making contact with the children. In September of 2013 //// filed another Injunction for Protection against Kelley and during that hearing Judge Ketchel granted the Injunction. Even with the Injunction in effect, Kelley continued to make contact with and ////// He gave them cell phones and used the cell phones to talk to them every day. During an interview with Kelley, after being advised of his rights, he advised that he didn't care and would do it again and again in reference to making contact with them. He further advised it doesn't matter what the judge said. He advised he did purchase a phone for //// and stated that he has picked the children up and has taken them to his house. Kelley admitted to picking up the kids up from school without their mother's knowledge and or permission. Further, another victim, was going to Kelley's residence to swim during the summer of 2013. Kelley would pick her up and take her to his residence. On the week of July 28, 2013, was at Kelley's residence and was in a swimsuit. Kelly looked at her and told her that her breast look nice when she wears her swimsuit. On or about the 4th week of August she was swimming in the pool and Kelley swam up behind her, pulled her underwater and touched/grabbed her breast. During her interview ////advised there was no doubt in her mind that Kelley grabbed her breast intentionally. On at least one occasion Kelley purchased cigarettes for ////and gave them to her to smoke. Sometime during the month of July, Kelly had to take some friends home and ask her to ride with them because he needed her help at the store. After dropping his friends off, was by herself in the truck with Kelley and they did go to the Dollar General Store. After leaving the store, he ask she knew where he used to live and she told him, "No". Kelley turned onto E. Dogwood Drive in Crestview, Florida, Okaloosa County and drive .7 of a mile to a dead end, cul-de-sac, and stopped the truck. Kelley got out of the truck and told ////to get out and she refused, and he got back in. He then told her she was growing up and he wanted to show her how it felt to be touched. Kelley then tried touching had to tell Kelley to stop twice before he stopped, and he then told her, "Don't take it too serious" and also told her he would get her anything she wants, which included a two piece swimsuit, candy, and food. On more than one occasion while at his house, Kelley offered marijuana and beer to which she refused. Also, another victim. met Kelley in June of 2013. She would go swimming at Kelley's residence with Kelley would buy karburst" and she liked them. On one occasion while swimming in the pool, Kelley pulled her underwater and grabbed her breast and attempted to grab her vagina, but she didn't let him.
