**OCSO STREET CRIMES UNIT ARRESTS FOUR FOLLOWING EXECUTION
OF SEARCH WARRANTS ON PELHAM ROAD**



Dexter Pierson

Two narcotics search warrants were executed Friday night (December 6th) at a Fort Walton Beach area home by members of the Okaloosa County Sheriff's Office Street Crimes Unit, with assistance from members of the O.C.S.O. Criminal Investigations Division, Multi-Agency Drug Task Force, and K-9 Unit.

During the investigation at 229 Pelham Road it was discovered that crack cocaine was being sold there by 54-year old Dexter Pierson. Investigators discovered a separate trailer on the property was being utilized by Pierson's customers as a safe haven to use the recently purchased crack cocaine.

Pierson was detained, along with other subjects found at his house. One individual was located in the separate trailer along with three others found to be loitering on the property.

During the search of the residences, deputies located evidence of the distribution and use of "crack" cocaine. Pierson has now been charged with Possession of Crack Cocaine with Intent to Distribute Within 1000 Feet of a Daycare, Public Nuisance (maintaining a place where narcotics are used, sold, or kept), and Possession of Drug Paraphernalia. 28-year old Chad Grey of Fort Walton Beach, 36-year old Dishawn Shaw of Milton, and 54-year old Bruce King of Fort Walton Beach were also arrested on drug paraphernalia charges.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On Dec 6, 2013 a narcotic search warrant was executed for the single family residence, located on the property of 229 Pelham Road, Ft Walton Beach, Florida. This search warrant was approved and signed by Judge Grinsted.

Upon execution of said search warrant several occupants were detained, including Dexter Pierson.

During a search of the residence, a plastic bag containing approximately 15 grams of crack cocaine, and a medicine bottle containing approximately 2 grams of cocaine, was located inside the bedroom which Pierson stated was his.

During post Miranda interview, Pierson admitted to selling crack cocaine from inside his residence. Furthermore Pierson

admitted to ownership of the crack cocaine located inside his bedroom, totaling approximately 17 grams.

According to the Okaloosa County Geographical Information System, 229 Pelham Road is located approximately 600 feet from Youth Village Incorporated, located at 312 Pelham Road, Ft Walton Beach, Florida.

My investigation, which is based on statements from the defendant, co-defendants, my observations, and collection of physical evidence, revealed Dexter Ladd Pierson, did violate F.S.S. 823.10(1)- Keeping Public Nuisance for Drug Activity, F.S.S. 893.13(1c1)- Possession of crack cocaine with intent to sell within 1000 feet of a day care, and F.S.S. 893.147(1)- Possession of Drug Paraphernalia. This incident occurred in Okaloosa County, Florida.
