## **OCSO DRUG TASK FORCE SEARCH WARRANTS NET FIVE ARRESTS**

During the early morning hours of Friday February 22<sup>nd</sup>, the Okaloosa County Multi-Agency Drug Task Force executed three narcotics search warrants. The first narcotics search warrant was served at 1629 Sandalwood Drive in Destin. A search of this residence revealed marijuana and drug paraphernalia.

- Denise Margaret Spier, DOB 01/03/1963 was arrested and charged with sale of marijuana within 1000' of a place of worship, trafficking in Oxycodone and possession of drug paraphernalia.

The second narcotics search warrant was executed at 11 Eglin Street, Fort Walton Beach. A search of this residence revealed marijuana, drug paraphernalia and other suspected controlled substances.

- Travis Jonathan Stover, DOB 02/18/82 was arrested and charged with sale of marijuana within 1000' of a place of worship, sale of marijuana and possession of drug paraphernalia.
- Kylie Justine Baker, DOB 08/21/89 was arrested and charged with possession of marijuana with intent to distribute and possession of drug paraphernalia.

The third narcotics search warrant was executed on at 951 McFarland Street, Apartment 20, Fort Walton Beach. A search of this residence revealed cocaine, marijuana, and drug paraphernalia.

- Corey Vondale Smith, DOB 10/08/77 was arrested and charged with possession of cocaine with intent to distribute within 1000' of a public park, possession of marijuana less than 20 grams and possession of drug paraphernalia.

In the month of February 2013, I along with members of the Multi Agency Drug Task Force executed a search warrant at 629 Sandlewood Drive Destin, FL, in relation to a narcotics investigation. The suspect is identified as Denise Spier.

During the course of this investigation a series of controlled drug buys to include purchases of marijuana and Oxycodone were conducted with Spier at the residence listed. These controlled drug buys were conducted following a set of established procedures. The amount of Oxycodone purchased from Spier weighed approximately 12 grams. As a result of this investigation, I obtained a search warrant for the residence listed above.

On February 21, 2013, I along with members of the Drug Task Force executed a search warrant at Spier's residence. A search of the residence revealed a large quantity of marijuana estimated to be approximately ten (10) ounces, smoking devices, and other items of paraphernalia were located inside of the residence. Based on my knowledge, training, and experience the amount of marijuana seized from the residence is an amount consistent with persons involved in the distribution of marijuana. It should be noted that Spier's residence is located within 1000ft of First Baptist Church of Destin, located at 201 Beach Drive Destin, FL.

During a post Miranda interview, Spier advised she was involved in the distribution of marijuana and further advised that she does receive packages of marijuana via mail service. Spier advised that all of the marijuana found inside of the residence belonged to her.

Based on the information, evidence, and Miranda interview I have reason to believe and do believe the defendant Denise M. Spier, did in fact violate F.S.S. 893.135 (1c1) trafficking in opiates, F.S.S. 893.13 (1e2) sale of marijuana within 1000 feet of a place of worship, F.S.S. 893.13 (1a1) possession of marijuana with intent to distribute, and F.S.S. possession of paraphernalia. This offense occurred in Okaloosa County, Florida.


