CRESTVIEW MAN CHARGED WITH AGGRAVATED ASSAULT WITH A DEADLY WEAPON



A Crestview man faces multiple charges following an overnight disturbance at his home on Adams Road.

38-year old Robert Miles Collinsworth is charged with aggravated assault with a deadly weapon, aggravated battery, battery, and resisting arrest with violence.

Deputies were called to the home around two a.m. and told Collinsworth was inside a bedroom with a gun and a juvenile. Deputies say Collinsworth had beaten and kicked a woman inside the home, and then attacked his live-in girlfriend when she tried to intervene. The two women fled to a bedroom where the juvenile was sleeping in an attempt to get away from Collinsworth, who reportedly had a long gun. They say he attacked his girlfriend again, breaking one of her ribs.

When deputies arrived, Collinsworth was in the bedroom with the teen and weapons. After multiple attempts to get him to surrender, Collinsworth came out unarmed and was taken into custody.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On February 26, 2013 I responded to 2967 Adams Rd Crestview, Florida Okaloosa County in reference to a disturbance in progress. Upon arrival it was learned the defendant Robert Collinsworth was located inside a bedroom along with [REDACTED] There were two females Tamara Carter and Deborah Parker also inside the residence. Parker and Collinsworth live at the above address as a family unit along with [REDACTED] The two have been in an eleven year relationship.

An investigation into this incident revealed that Collinsworth had battered Carter by intentionally striking her in the face with a closed fist against her will. He also struck Carter several times by kicking her in the face while they were on the floor in an altercation. As a result of being struck Carter suffered a laceration to the eyebrow area of her left eye and swelling and bruising to her left cheek. During this altercation, Parker attempted to stop the incident which resulted in her also being struck and kicked by Collinsworth several times. This incident continued into a hallway, bathroom, and bedroom. While retreating to the bathroom, Carter observed Collinsworth with a long gun in his possession which placed her in great fear of being seriously injured or possibly even death. In an attempt to retreat from Collinsworth, Parker and Carter entered a bedroom where a [REDACTED] juvenile was sleeping. Collinsworth then forced his way into the bedroom where he again battered Parker by pushing her out the bedroom door into a hallway and into a table. As a result of being pushed into the table and or kicked by Collinsworth Parker suffered a break to the seventh rib on her right side which needed medical attention.

Upon arrival of law enforcement Collinsworth was found to be in a bedroom with [REDACTED] with the door closed and weapons inside the room. Several attempts were made by numerous law enforcement officers to call Collinsworth from the room to surrender. These attempts were ignored by Collinsworth for approximately thirty minutes before he did surrender unarmed and was arrested.

Based on the above information I have reason to believe and do believe the defendant Robert Collinsworth violated F.S.S. 784.021(1a) Aggravated Assault, 784.03(1a1) Battery, 784.045 Aggravated Battery causing great harm, and 843.01 Resisting an officer with violence. These offences did occur in Okaloosa County Florida where the affiant is a sworn law enforcement officer.
