DRUG TASK FORCE ARRESTS TWO IN SHALIMAR **FOLLOWING SEARCH WARRANT**



The Okaloosa County Multi Agency Drug Task Force (DTF) conducted a narcotics search warrant at 121 Poquito Road in Shalimar early this morning (February 5).

Arrested from the residence were 48-year old Jon Dewitt King and 38-year old Maggie King, both of 121 Poquito Road in Shalimar. Both subjects were charged with possession of marijuana with intent to distribute, possession of a controlled substance and possession of drug paraphernalia. Investigators seized several pounds of marijuana as well as other controlled substances and drug paraphernalia from the residence.

The Okaloosa County Multi-Agency Drug Task Force is comprised of members of the Okaloosa County Sheriff's Office, Florida Department of Law Enforcement, Niceville Police Department and the Drug Enforcement Administration.

PROBABLE CAUSE

On February 5, 2013, I along with members of the Multi Agency Drug Task Force executed a search warrant at 121 Poquito Road Shalimar, FL, in relation to a narcotics investigation. The suspects identified in this case are Jon King and Maggie King.

Since November 2011, a narcotics investigation was conducted involving the suspects Jon and Maggie King distributing marijuana from their residence identified as 121 Poquito Road Shalimar, FL. As a result of the investigation, a search warrant was obtained for the residence and was signed by the honorable Judge Maney.

After making entry into the residence a search of the residence was conducted by members of the Drug Task Force. A search of the residence revealed the following evidence: approximately 5 pounds of suspected marijuana, multiple prescription bottles with different brands of Xanax (Schedule IV), digital scales and large plastic bags with marijuana residue, other suspected controlled substances that will be sent to FDLE for chemistry analysis, and documents. A field test of the suspected marijuana using a NARK field test kit provided a positive response for the presence of THC. The amount of marijuana seized and its packaging indicate to this officer someone that is involved in the distribution of marijuana. The suspected Xanax was positively identified as Xanax (Schedule IV) via DrugId.com.

During a post Miranda interview, Maggie King advised that she did not wish to talk about the marijuana found inside the residence or the prescription medication found inside the master bedroom.

Based on information, evidence, and Miranda interview I have reason to believe and do believe the defendant Maggie King did in fact violate F. S. S. 893.13 (1a1) possession of marijuana with intent to distribute, F. S. S. 893.13 (6a) possession of a controlled substance, and F. S. S. 893.145 (1) possession of paraphernalia. This offense occurred in Okaloosa County, FL.

PROBABLE CAUSE

On February 5, 2013, I along with members of the Multi Agency Drug Task Force executed a search warrant at 121 Poquito Road Shalimar, FL, in relation to a narcotics investigation. The suspects identified in this case are Jon King and Maggie King.

As a result of the investigation, a search warrant was obtained for the residence and was signed by the honorable Judge Maney.

After making entry into the residence a search of the residence was conducted by members of the Drug Task Force. A search of the residence revealed the following evidence: approximately 5 pounds of suspected marijuana, multiple prescription bottles with different brands of Xanax (Schedule IV), digital scales and large plastic bags with marijuana residue, other suspected controlled substances that will be sent to FDLE for chemistry analysis, and documents. A field test of the suspected marijuana using a NARK field test kit provided a positive response for the presence of THC. The amount of marijuana seized and its packaging indicate to this officer someone that is involved in the distribution of marijuana. The suspected Xanax was positively identified as Xanax (Schedule IV) via DrugId.com.

During a post Miranda interview, Jon King identified the weight of the marijuana as being 4 pounds which was found in the safe located in a closet found in the master bathroom. Jon King stated that he takes pain medications for back pain. Jon King did not provide any information in reference to distributing marijuana from the residence.

Based on information, evidence, and Miranda interview I have reason to believe and do believe the defendant Jon King did in fact violate F. S. S. 893.13 (1a1) possession of marijuana with intent to distribute, F. S. S. 893.13 (6a) possession of a controlled substance, and F. S. S. 893.145 (1) possession of paraphernalia. This offense occurred in Okaloosa County, FL.
