# **BUSINESS BURGLAR CAUGHT IN THE ACT**



Deputies responding to a call of a burglary in progress Wednesday night caught a man inside the convenience store with a hammer, flashlight, screwdriver and gloves.

The doors were locked, the power was off, and a window was broken at the Corner Food Market at 100 Bob Sikes Boulevard when deputies arrived around eleven p.m.

They found a hole in the wall between two inside units and 45year old David Eugene Vaughn hiding inside.

Vaughn is charged with burglary and possession of burglary tools.

Deputies are investigating whether or not Vaughn is connected to a rash of other area burglaries.

#### [STATEMENT OF PROBABLE CAUSE / NAFRATIVE ]

On 01/02/13, I responded to 100 Bob Sikes Blvd. Fort Walton Beach, FL 32547 in reference to a burglary in progress. All exterior doors to the building were locked and the power was off. A broken exterior window was found in unit A and entry was made to the building. A kole was found the wall which unit A and B shared. Upon entering unit B the defendant David Eugene Vaughn was found hiding in the convenience store. Vaughn was found in possession of a hammer, flashlight, screwdriver, and a pair of gloves.

Contact was made with Fredrick Forte, Monjur Hossin, and Ruhul Amin who all provided verbal and sworn statements saying no one had permission to be inside either unit.

A further check of the building found three out of the four master breaker switches outside were turned off. When theses switches were turned on the power returned to unit A.

Based on the above information I have reason to believe the defendant David Eugene Vaughn did violate F.S.S. 810.02(4)(a) burglary, and F.S.S. 810.06 possession of burglary tools. This incident occurred in Okaloosa County where I am a sworn law enforcement officer.
