# NICEVILLE MAN CHARGED WITH STEALING AND WRECKING BREAD TRUCK



A Niceville man is facing multiple charges after deputies say he stole a bread truck on New Year's Day, refused to stop during a pursuit, and then wrecked the vehicle into a drainage ditch.

24-year old Matthew Ryan Lambert of 750 St. John Cove in Niceville is charged with resisting arrest, grand theft of a motor vehicle, driving with a suspended license, possession of marijuana and possession of drug paraphernalia.

Deputies say Lambert took the truck, owned by Flowers Baking Company of Green Acres Road, from the Fill Ups Food Store on Emerald Coast Parkway in Destin around 4:30 p.m. He was spotted driving north on State Road 293 at a high rate of speed. A deputy tried to stop Lambert, but Lambert refused to pull over. He ran a red light at State Road 20, then headed west until he reached the Whataburger at 4450 State Road 20. He turned into the parking lot there and crashed into a drainage ditch. He was taken into custody.

The bread truck sustained approximately \$8000 in damages.
