## **ALERT NEIGHBOR FOILS BURGLAR GET-AWAY**



A Fort Walton Beach man is charged with multiple felonies after an alert neighbor thwarted his attempt to get-away from a home being burglarized.

23-year old Timothy Andrew Woods II of 300 23<sup>rd</sup> Street in Niceville is charged with aggravated assault, battery, displaying a weapon during commission of a felony, burglary, criminal mischief, and petty theft.

Deputies who went to the scene of a burglary in progress at 873 Culp Avenue in Fort Walton Beach found witnesses had Woods detained.

A neighbor told deputies he heard glass breaking from a home nearby around 9 p.m. and went to investigate. He saw Woods looking at him through a window. Woods then ducked out of sight and locked the door. The neighbor took the keys from Woods' vehicle that was parked outside and still running. A few minutes later, Woods came around to the front of the house and demanded his keys. The neighbor refused but says Woods threatened him and said he had a gun. The man shoved Woods and says Woods then hit him in the head and tried to take his phone.

Another witness says Woods threw a bag towards the fence prior to deputies arriving. Deputies found the bag, which contained a loaded .38 caliber handgun.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On 1/2/2012 I responded to 873 Culp Ave Ft Walton Beach, Okaloosa County, Florida in reference to a burglary in progress. Upon arrival, witnesses had the suspect, Timothy Andre Woods II (defendant) already detained and I took him into custody.

The neighbor, Robert Lee Bolton (victim) advised that he heard glass breaking from the back side of his neighbors residence. He went to investigate, calling for the owner Tyler by name. As he approached the front door he observed a black male, later identified as Woods, look at him through the window. He said the male then ducked back inside and locked the door. Bolton took the keys from Woods' vehicle, that was parked outside the residence and still running. Several moments later, Woods walked around front from the back side of the residence.

Bolton advised that Woods demanded the keys for the vehicle back and Bolton did not return the keys. At that time, Woods possessed a blue bag and told him "I get something for you" and told him he had a gun. Bolton said that he shoved Woods away and Woods struck him in the head with a closed fist and tried to take Bolton's phone to keep him from calling the police. He told him that he would not shoot him if he gave him back his keys so he could leave. Bolton advised that he was in fear for his life.

Another witness, Katie Dawn Schreffler (witness) advised she witnessed Woods with a blue "tote like" bag with black handles and Woods said, "I got something for ya'll". She advised that just prior to my arrival, he threw the bag towards the fence.

After a brief search, a blue tote bag was located just over the fence. Inside the bag was a loaded, Smith and Wesson 38 caliber revolver.

I advised Woods of his Miranda Warning from a prepared text. He acknowledged that he understood his rights and knowingly, intelligently and voluntarily waived his rights and agreed to answer questions. When asked why he was inside the house, he said that he was never inside the residence. He was outside and he was there looking for Tyler, who was a friend of his. He said he was at the residence alone. He also stated that he never struck Bolton and he was never in possession of the blue bag described by witnesses.

The rear window to Sandstrom's residence was broken out and in the yard I located a controller to a Playstation III video console.

Tyler Joseph Sandstrom (victim) arrived and advised that he does not know Woods and neither Woods nor anyone else had permission to be inside his residence or on his property. Sandstrom valued the controller at \$30.00 and the damage to the window at approximately \$100.00

Based on the above information, I have reason to believe that Timothy Andre Woods II did violated F.S.S. 810.02.4a Burglary to an unoccupied structure, F.S.S. 790.07.2 Possession of a firearm during the commission of a felony, F.S.S. 784.021.1b Aggravated Assault during the commission of a felony, F.S.S. 812.014.3a Theft and 784.03.1a1 Battery, 806.13.1b1
