## **DEPUTY SPOTS SUSPECTED MALL SHOPLIFTER IN GROCERY STORE PARKING LOT**



A Pensacola woman is charged with grand theft and possession of marijuana after an alert Okaloosa County Sheriff's Deputy spotted the shoplifting suspect in a grocery store parking lot.

The deputy heard a call for a theft in progress from the Dillard's at Santa Rosa Mall Saturday evening. He soon spotted a car matching the suspect car description in the Food World Parking lot across the street.

He made contact with the female driver, 22-year old Shaquita Booker of Pensacola. An OCSO K-9 called to the scene alerted to the presence of narcotics inside Booker's car. The search turned up marijuana and bags of clothing, including nearly a thousand dollars worth of Polo shirts believed stolen from Dillards.

Video surveillance revealed Booker had had help with the crime from a man inside the store, but his identity is not yet known.

Deputies took possession of more than \$3300.00 worth of clothing until victims can be identified.

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On 07/27/13, I responded to the area of Santa Rosa Mall 300 Mary Esther Blvd. Mary Esther, FL 32569 in reference to a retail theft in progress. I was informed by dispatch the suspects were a black male on foot and a black female driving a gray Dodge Avenger with a Texas temporary tag of BJQ664. I observed a gray Dodge Avenger with a Texas tag of BJZ6624, in the parking lot of Food World, with the defendant Shaquita Shuntevia Booker in the driver seat. She was the only occupant of the vehicle.

Booker exited the vehicle, was detained and read the Miranda Warning. Booker advised her ID was in the center console of the vehicle and gave me verbal consent to get the ID from the center console. When I open the door I immediately smelled an odor, based on my training and experience, I knew to be burnt marijuana. OCSO K9 Drako conducted a walk around of the vehicle and a positive alert was given. Upon searching the vehicle I noticed a receipt in the passenger side door which contained a green leafy substance. A field test of this substance yielded a positive result for the presence of THC. It weighed approximately 1 gram.

I made contact with Robert Long who is the Loss Prevention Officer at Dillard's. Per verbal and sworn affidavit of complaint Long observed Booker and a black male enter the store with Booker carrying a JCPenny's bag. Booker and the male went to a display table and both placed several Ralph Lauren Polo shirts in the bag Booker was

holding. The then exited the store without making a payment for the shirts. Long also provided me with video surveillance which showed Booker and the black male placing the shirts in the bag and exiting without making a payment.

I made contact with Booker at booking and advised her the Miranda Warning was still in place. Booker agreed to talk without a lawyer present. Booker admitted to stealing the shirts from Dillard's with the black male. Booker said the marijuana and tapped bags belonged to someone else.

Based on the above information I have reason to believe the defendant Shaquita Shuntevia Booker did violate F.S.S. 812.014(2)(c) grand theft and 893.13(6)(b) possession of marijuana less than 20 grams. This incident occurred in Okaloosa County where I am a sworn law enforcement officer.
