OCSO CHARGES TWO CRESTVIEW RESIDENTS WITH THREE COUNTS OF CHILD NEGLECT

The Okaloosa County Sheriff's Office arrested two Crestview residents on charges of child neglect without great bodily harm, possession of marijuana and possession of drug paraphernalia.

A deputy responding to a call of a man waving his arms as if in distress on Aplin Road Saturday afternoon went to a nearby home to see if anyone had information on the individual.

The door was wide open and two people came forward. They said the man waving his arms was a relative. The deputy says in talking to the pair, later identified as Justina and David Rush, he noticed the home was in an advanced state of disrepair and filth.

Children were found to be in the home where thousands of spiders, roaches, and ants were crawling on the walls, floors, and ceilings. Neither toilet was operable and dirty diapers were in various rooms. An infant in a bed had multiple cockroaches crawling on it. The deputy reported the carpets were filthy with

ground-in food, dirt and what appeared to be vomit. A stench of vomit was noticeable. In a baby's bassinet he found two bottles containing spoiled formula and a bottle of some type of medicine.

27-year old David Blane Rush and 24-year old Justina Nicole Rush, both of 2925 Aplin Road, were taken into custody on the child neglect and drug charges. PAWS also confiscated an emaciated dog tied to a tree in the backyard.

In addition, while at the home, the deputy also noticed a small



marijuana plant growing in a pot on a bedroom floor. 43-year old James Franklin Feagin ran to the plant, pulled it from the pot, and shoved it into his mouth. He then tried to run from the bedroom and refused to spit it out. Feagin is charged with resisting an officer without violence, cultivation of marijuana, and destroying or tampering with evidence.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On July 27, 2013 the defendant, James Franklin Feagin, did commit the criminal offenses of Cultivation of Marijuana, Destruction of Evidence & Resisting an Officer Without Violence.

On the above mentioned date the defendant was identified as a resident of the home located at 2925 Aplin Road Crestview FL during an investigation of possible child neglect. While performing a walk through of the residence the defendant was observed entering a bedroom that he identified as being his bedroom. Upon entry into the room I immediately noticed a small live marijuana plant growing in a pot on the bedroom floor. The defendant immediately ran toward the marijuana plant, pulled it from the pot and shoved it into his mouth. The defendant then attempted to flee from the bedroom and I grabbed him by his arm commanding that he spit out the plant. The defendant ignored my commands and continued to chew and swallow the marijuana plant. The defendant also continued to pull away from me and attempt to flee the bedroom. After ignoring several commands to stop, the defendant was tased and secured into handcuffs.

The root system from the marijuana plant was still intact inside of the pot and was recovered as evidence.

These offenses did occur within Okaloosa County and are direct violations of F.S.S. 893.13(1)(a)(2) Cultivation of Marijuana, 918.13(1)(a) Destruction of Evidence & 843.02 Resisting an Officer Without Violence.
