#### FWB MAN CHARGED WITH LEWD AND LASCIVIOUS EXHIBITION



The Okaloosa County Sheriff's Office has charged a Fort Walton Beach man who'd been classified as a sexual offender back in 1997, with lewd and lascivious exhibition in the presence of a victim less than sixteen years of age.

59-year old Isidoro Alvarez Moreno of 730 Mayflower Avenue was arrested May 30<sup>th</sup> and taken to the Okaloosa County Jail in Crestview.

Two juvenile girls reported witnessing Moreno masturbating on May 24th while he was sitting in a rolling chair in the doorway of a home on Winter Park Court in Fort Walton Beach. They also say he was rubbing his genitals as he walked up and down the street. In addition, an adult female also reported observing Moreno touching himself in the doorway of the home.

Moreno was classified as a sexual offender in September 1997 after being found guilty of lewd and lascivious acts in the presence of a child under sixteen.
