THREE MEN CHARGED WITH AGGRAVATED ASSAULT WITH A DEADLY WEAPON IN THREE SEPARATE INCIDENTS

The Okaloosa County Sheriff's Office has arrested three local men on charges of aggravated assault with a deadly weapon in three separate incidents over the last two days.

The first arrest took place June 3rd at 3850 Indian Trail in Destin. 44-year old Alfred George Price of 813 Main Street is accused of intentionally pointing a shotgun at his roommates and screaming that he was going to kill them. The roommates say they fled for their lives while yelling and stomping on the floors to alert neighbors at the apartment complex. Multiple neighbors heard the screams for help and called the Sheriff's Office.

Deputies found a 12 gauge shotgun and Glock .22 handgun in Price's room. He is charged with aggravated assault with a deadly weapon without intent to kill (DOMV) and violation of a domestic violence injunction that prohibited him from possessing firearms.

In a second unrelated incident, the OCSO has charged 32-year old Enrique Jamah Hill of #9 Sixth Avenue in Shalimar with aggravated assault with a deadly weapon without intent to kill (DOMV) and possession of a firearm under the influence of alcohol.

Deputies were called to 40 Eglin Street June 3rd in reference to an armed disturbance in progress. Deputies say Hill's girlfriend told them he'd been drinking alcohol all afternoon and while she was outside talking to

neighbors, Hill came out with a shotgun and began waving it around. She says he went back into the home and she heard a shotgun noise. Deputies found a hole on the top of a dresser inside the bedroom closet and in a flat screen tv in the bathtub. The shotgun was found between the mattresses in the bedroom.

The third incident took place in the early morning hours of June 4th at Cedars Condominiums, 209 West Miracle Strip Parkway in Mary Esther.

28-year old Joseph Ryan Dobson is accused of pointing a gun at his fiancé and a friend after watching a documentary on Adolph Hitler. Dobson's fiancé says he then pointed the weapon towards the ceiling and fired two shots. Deputies found Dobson inside the condominium on the bedroom floor, highly intoxicated. Dobson is charged with aggravated assault with a deadly weapon without the intent to kill (DOMV) and discharging a firearm while under the influence of alcohol.

No one was injured in any of the three incidents.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 06/03/2013, Okaloosa County Sheriff's Office Deputies responded to an Armed Disturbance at 3850 Indian Trail Apt 206, Destin, Florida where the defendant Alfred Price intentionally pointed a black Shotgun at his roommates, Ted Barnett and Susan Barnett, and screamed that he was going to kill them. The defendant's actions did cause the victims, Ted and Susan, to fear for their lives.

Per sworn written statements from the victims and other witnesses, the defendant began screaming loudly and throwing furniture around the apartment. When Susan Barnett went to see what the commotion was about, the defendant threw a Shotgun Shell at her feet, yelled "You think I won't use this," and "Get the hell out you're evicted" while pointing

a Shotgun at Susan and Ted. The defendant then finally stated "I'm going to kill everyone." A Witness, John Bazylak, was in the apartment at the time and heard the defendant yell "They're all going to die." Both of the victims and the witness fled for their lives while yelling and stomping on the floors to alert neighbors. Multiple neighbors overheard the screams for help and contacted law enforcement.

A check through FCIC/NCIC revealed that the defendant was served with a Domestic Violence Injunction (Case No. 2012-DR-005690-FV) on 12/28/2012 with an expiration of 06/28/2013 which was ordered by Judge William F. Stone in Okaloosa County, Florida. The injunction indicated "Respondent shall not use or possess a firearm or ammunition." A black Mossberg 500 12 Gauge Shotgun and a Glock 22 .40 S&W Handgun were located in the defendant's room. Ammunition was found in both weapons; however, there was not a round in the chamber of either.

Based on the above stated facts, I have probable cause to believe and do believe the defendant, Alfred Price, willingly, knowingly, and unlawfully committed two counts of Aggravated Assault with a Deadly Weapon without intent to kill in violation of F.S.S. 784.021(1a) by displaying a Shotgun and making threats against the victims. I also have probable cause to believe and do believe that the defendant knowingly committed a violation of F.S.S. 741.31(4b) Violation of Injunction for Protection Domestic Violence by intentionally being in possession of a firearm and ammunition after being served with a Domestic Violence Injunction.

This offense did occur in Okaloosa County, Florida where your affiant is a sworn Law Enforcement Officer.

On 4 June 2013 I responded to an armed disturbance call at Apt 304B, 209 Miracle Strip Parkway, Mary Esther, Florida.

The victim, Ms. Alysha Cylke indicated in a sworn written statement that the suspect, Mr. Joseph Dobson had pointed a loaded 9mm handgun at her and her friend, and that he had fired that weapon into the ceiling of the apartment twice. She said a struggle took place when she tried to disarm the suspect and the gun went off during the struggle hitting a microwave in the kitchen.

The suspect was highly intoxicated upon contact and indicated that he has no recollection of what occurred during this incident.

The victim and the suspect live together as a family and are engaged to get married.

The physical evidence located in the apartment was consistent with two gunshots being fired into the ceiling and a microwave in the kitchen was damaged by a gunshot.

Based on the physical evidence I observed on scene in the way of the gun shot holes in the ceiling and the microwave that was shot, and the victims statement, I have reason to believe and do believe that the defendant has committed the offenses of Aggravated Assault (DOMV) with a deadly weapon without the intent to kill, and discharging a firearm while intoxicated, which are in violation of F.S.S. 784.021.1a and F.S.S. 790.151 respectively.

This incident did occur in Okaloosa County where I am a sworn law enforcement officer.



McCloskey stated she was in fear for life and did fear Hill was going to shoot her. McCloskey then saw Hill run into the house. A few short moments later she heard the shotgun being discharged. McCloskey advised she saw Hill drink numerous amounts of alcohol prior to the incident. McCloskey advised she does live with Hill as a family unit and they do have a child in common.

I observed a hole on the top of a dresser inside unit G's bedroom closet. I also observed a hole on the back of a flat screen T.V. which was found in the bathtub. I located the shotgun between the mattress in the bedroom.

Victim Sarah Smith stated in a sworn written statement, she witnessed Hill wave a black in color shotgun in their direction. She stated she was in fear for her life and feared Hill would shoot her. A few moments later she witnessed Hill walk back into the residence and at which point she heard a loud shotgun bang.

Victim Douglas Spencer stated in a sworn written statement, he witnessed Hill wave a black in color shotgun in his direction. He stated he was in fear for his life and feared Hill would shoot him. A few moments later he witnessed Hill walk back into the residence and at which point he heard a loud shotgun bang.

Post Miranda, Hill stated he was cleaning his gun when the gun went off. Hill also admitted he was drinking prior to this incident. Hill admitted he was living with McCloskey as a family unit and they do have a child in common.

Based on the above information, I believe Defendant Enrique Hill did violate F.S.S 784.021.1A Aggravated Assault with a Deadly Weapon without the intent to kill (DOMV), Aggravated Assault with a Deadly Weapon without intent to kill (2 Counts), and F.S.S 790.151.3 Use of a Firearm while under the influence. This offense did occur in Okaloosa County Florida were your affiant is a sworn law enforcement officer.
