## OCSO ARRESTS MILTON MAN FOR ARMED HOME INVASION



The Okaloosa County Sheriff's Office has charged a Milton man with armed home invasion robbery, aggravated battery with a deadly weapon, and felony violation of community control. The suspect, 30-year old Douglas Scott Martin, is accused of attacking a Holt couple Saturday evening at their home on Wallman Lane.

Victims Arlie and Joyce Grice say a man with his face painted black, wearing camos and a hoodie, rushed into their home after Arlie Grice responded to a knock at the door around 9:39 p.m. Saturday. The man, who also had a knife, hit Grice numerous times with an axe handle and began demanding money. He also hit Grice's wife. She was able to get out of the house and call 9-1-1.

When deputies arrived, the man had fled but two OCSO K-9 Units began working a track. The suspect had left behind the axe handle, a glove, and bloody shirt. A deputy later noticed a man without a shirt on who matched the suspect's description in the parking lot of Brown's Grocery Store on West Highway 90 in Holt and made contact. The individual was later identified as Martin. Martin told investigators the home invasion was

"a prank".

52-year old Arlie Grice was transported to North Okaloosa Medical Center with injuries. Martin is being held at the Okaloosa County Jail in Crestview.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On June 1st, 2013 I responded to 495 Wallman Lane, Holt, Florida (Okaloosa County) in reference to a home invasion robbery that had already occurred. Per sworn affidavit of complaint and verbal statement the victim, Joyce Grice, stated she was in bed in her residence along with her husband, co-victim, Arlie F. Grice, when they heard a knock at the front door. A. Grice then opened the front door, at which time a male wearing some sort of black paint on his face, camouflage clothing, armed with an ax handle and a butcher style knife. The male struck A. Grice with the ax handle in the head and torso causing injuries. J. Grice observed the male standing over A. Grice and also heard him demanding money. A. Grice recognized the voice of the male as being the suspect, Duglas Scott Martin. D. Martin then took J. Grice

into the back bedroom where her struck her several times with the ax handle still demanding money. D. Martin struggled with A. Grice when A. Grice armed himself with an ax handle himself. During the struggle J. Grice fled the residence and called 911, at which time D. Martin fled the residence.

D. Martin was located in the parking lot of 531 W. US HWY 90 wearing jean shorts, shoes and no shirt. Post Miranda Warning D. Martin stated that he didput black paint on his face and was trying to "prank" A. Grice and J. Grice. Before knocking on the door to the Grice residence D. Martin armed himself with a knife and ax handle he found outside the residence. When A. Grice answered the door D. Martin stated that he struck A. Grice in the stomach area with the ax handle and then entered the residence. D. Martin also stated he asked A. Grice for money, at which time A. Grice began struggling with him. D. Martin stated that at no time did he tell A. Grice or J. Grice who he was and that the incident was a prank but continued to say "money" and continued the incident until he fled the residence when J. Grice called 911. D. Martin denied striking both J. Grice or A. Grice other than the initial strike to the stomach of A. Grice.

A. Grice was admitted to North Okaloosa Medical Center with injuries to his head, torso, and a punctured lung At the time of the incident D. Martin was on felony community control on 01/03/2013 for Burglary and Theft.

Based on the information obtained I have reason to believe and do believe the defendant, Douglas Scott Martin, did violate F.S.S. 812.135 Home Invasion Robbery, F.S.S. 784.045 1(a)(2) Aggravated Battery (x2), and F.S.S. 948.06 Violation of Community Control. These offenses did occur in Okaloosa County Florida.
