## **FWB MAN CHARGED WITH LEWD AND LASCIVIOUS EXHIBITION**



The Okaloosa County Sheriff's Office has charged a Fort Walton Beach man who'd been classified as a sexual offender back in 1997, with lewd and lascivious exhibition in the presence of a victim less than sixteen years of age.

59-year old Isidoro Alvarez Moreno of 730 Mayflower Avenue was arrested May 30<sup>th</sup> and taken to the Okaloosa County Jail in Crestview.

Two juvenile girls reported witnessing Moreno masturbating on May 24th while he was sitting in a rolling chair in the doorway of a home on Winter Park Court in Fort Walton Beach. They also say he was rubbing his genitals as he walked up and down the street. In addition, an adult female also reported observing Moreno touching himself in the doorway of the home.

Moreno was classified as a sexual offender in September 1997 after being found guilty of lewd and lascivious acts in the presence of a child under sixteen.

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On September, 22, 1997, Isidoro Alvarez Moreno was adjudicated guilty in Okaloosa County criminal case for Lewd and Lascivious Acts on or in the presence of a Child Under 16, Case #97-586. Based on this adjudication Moreno was classified as a Sexual Offender

On May 24, 2013, Moreno was at 2406 Winter Park Court, Fort Walton Beach, Florida. 2406 Winter Park Court is part of a town home complex. The front door [REDACTED]

On May 24, 2013, Moreno stood in the open doorway [REDACTED] Moreno pulled his pants down. Moreno then began masturbating his penis in full view of the 12 and 13 year old girls who were sitting [REDACTED]

Several times during the day Moreno would walk by the girls and grab and or rub his genitals through his pants.

An [REDACTED] returned home prior to Law Enforcement being called, observed Moreno standing

in the doorway of 2406 Winter Park Court rubbing his genitals through his pants.

Based upon my investigation which included interviews with the victims, witness and suspect, I believe Isidoro Moreno is in violation of Florida State Statute 800.04.7A1 Lewd or Lascivious Exhibition Intentionally Masturbates in the Presence of a Victim less than 16 Years of Age. This offence occurred in Okaloosa County, Florida.
