OCSO CRACKDOWN ON SYNTHETIC DRUG SALES SEEING SUCCESS




The Okaloosa County Multi-Agency Drug Task Force (DTF) attempted at least eighty-four purchases of controlled synthetic drugs from local convenience stores and specialty stores throughout Okaloosa County since spring break initiated. These drugs are commonly sold as "Spice, K-2, Bath Salts, Screen Cleaner, Plant Food, Lady Bug Attractant" and various other products and are purchased by people seeking the effects of marijuana, cocaine and other illicit drugs. Of the stores, only one was found to be openly selling these substances. After controlled purchases, and FDLE chemistry analysis, a search warrant was obtained for that location:

Gina's 99 Cents Store 11 Eglin Pkwy., Ft Walton Beach

The DTF executed a search warrant at that location Friday afternoon, (March 15th) seized packages of suspected controlled substances and arrested Fort Walton Beach resident 20 year old Luis Meza-Cruz of 325 Carmel Drive #21 for sale of controlled substance within 1000 ft of a church. (Arrest report attached). 43-year old Timothy Peters of Gulf Breeze is charged with sale of a controlled substance with intent to distribute. (continued on page two)

Investigators believe the dramatic decrease in establishments selling synthetic drugs during this most recent undercover operation indicates the Sheriff's Office's efforts to combat the sale of these dangerous substances in area businesses is having a substantial impact. In addition, many Okaloosa County business owners and/or their parent corporations are cooperating with those efforts by agreeing to stop the sale of these items through the OCSO's new Gold Star Retailer campaign and ongoing interactions. However the Drug Task Force will continue to aggressively monitor the situation.

Since January 2012, the Okaloosa County Sheriff's Office Drug Task Force has made 62 separate undercover buys of illegal synthetic drugs from local businesses, executed 22 search warrants, made four arrests with more pending, and seized eight vehicles along with more than \$625,000 in monies and \$2.9 million in inventory. This was **prior** to Friday's operation.

The Drug Task Force is comprised of Okaloosa Sheriff's Investigators, and officers from the Niceville Police Department and Florida Department of Law Enforcement.

[STATEMENT OF PROBABLE CAUSE / NAFRATIVE]

In the month of January 2013, your Affiant along with members of the Okaloosa County Multi-Agency Drug Task Force initiated an investigation into the distribution of large quantities of controlled synthetic cannabinoids and/or synthetic cathinones that was occurring in Okaloosa County, Florida.

The investigation focused on a store identified as Gina's 99 Cent Store located at 11 Eglin Pkwy SE, Fort Walton Beach, Florida 32548. The business is involved in the selling of synthetic Cannabinoids, Synthetic Cathinones and/or Synthetic Phenethylamines.

In an effort to further this investigation, your Affiant did act as an Undercover Police Officer (UC), to conduct a controlled purchase of suspected synthetic drugs from Gina's 99 Cent Store located at 11 Eglin Pkwy SE, Fort Walton Beach, Florida 32548.

On March 12, 2013, Your Affiant made a controlled purchase of synthetic cannabinoids, specifically "Maui" from Gina's 99 Cent Store located at 11 Eglin Pkwy SE, Fort Walton Beach, Florida 32548 utilizing a set of established procedures. Prior to the controlled purchase, surveillance was established at Gina's 99 Cent Store located at 11 Eglin Pkwy SE, Fort Walton Beach, Florida 32548. This controlled purchase was made within a very close proximity to a place of worship as

the business is located in the same business as the "Spirit of Christ" church.

The suspected synthetic cannabinoids "Maui" was sent to Florida Department of Law Enforcement Crime Lab for chemical analysis.

On March 13, 2013 your Affiant received information from the FDLE chemistry analysis of the "Maui" identifying the substance as XLR11 ((1-(5-fluoropentyl)-1H-indol-3-yl)(2,2,3,3-tetramethylcyclopropyl)methanone).

Previously on December 11, 2012, Florida Atbrney General Pam Bondi issued 2ERI2-1. This emergency rule specifically lists XLR11 ((1-(5-fluoropentyl)-1H-indol-3-yl)(2,2,3,3-tetramethylcyclopropyl)methanone) as a synthetic cannabinoid and makes it a Schedule I controlled substance in 893.03.

Also on December 11, 2012, According to the Fort Walton Beach Police Department, a Cease and Desist letter was issued to the employee on duty at Gina's 99 Cent Store located at 11 Eglin Pkwy SE, Fort Walton Beach, Florida 32548. The letter advised that pursuant to the new Emergency Rule 2ER12-1, any business or person who possesses, manufactures, distributes and/or sells these substances is subject to criminal prosecution and/or civil penalties as authorized by Florida Statutes.

The letter directed the business to immediately cease and desist the possession, manufacture, distribution and sale of these compounds and surrender forthwith any such compounds they may have in their possession to the Officer presenting them the letter.

As a result of this cease and desist letter, employees of the premises to be searched voluntarily relinquished a large amount of products suspected to be synthetic Cannabinoids, Synthetic Cathinones and Synthetic Phenethylamines. Specifically over 100 packets.

The employee on duty December 11, 2012 was the defendant, Luis Alberto Meza-Cruz. Meza-Cruz was also the employee that sold your affiant the controlled substance during the controlled purchase made on March 12, 2013. Post Miranda Meza-Cruz even positively identified himself in a picture that was taken during the transaction.

On March 15, 2013, I along with members of the Okaloosa County Multi-Agency Drug Task Force executed a narcotics search warrant at Gina's 99 Cent Store located at 11 Eglin Pkwy SE, Fort Walton Beach, Florida 32548. As a result of the search warrant, a large amount of controlled synthetic cannabinoids were located and seized. The products seized were the same name brands of products obtained in the early controlled purchase that resulted in the presence of controlled substances per 893.03.

Based on your Affiant's investigation, your Affiant has just and reasonable cause to believe, and does believe, that the above named defendant, Luis Alberto Meza-Cruz, violated F.S.S. 893.13.1e2, Sale of a Schedule I Controlled Substance within 1000 feet of a place of religious worship services: XLR11

((1-(5-fluoropentyl)-1H-indol-3-yl)(2,2,3,3-tetramethylcyclopropyl)methanone) as well as F.S.S. 893.13.1a2 Possession of Controlled Substance with intent to sell. This offense did occur in Okaloosa County, Florida, where your Affiant is a full time sworn Law Enforcement Officer.

[STATEMENT OF PROBABLE CAUSE / NAFRATIVE]

On March 15, 2013, members of the Okaloosa County Sheriff's Office Multi-Agency Drug Task Force conducted a buy bust operation for synthetic cannabinoids utilizing a confidential source, hereafter referred to as CS at Gina's 99 Cent Store located at 11 Eglin Parkway, Fort Walton Beach, Florida.

The CS made controlled telephone calls and text messages to the Defendant, TIMOTHY S PETERS, via cellular device and arranged for the purchase of approximately 3,750 grams of suspected synthetic cannabinoids in exchange for \$8,175 U.S. Currency.

Prior to PETERS arrival the CS received an incoming text message from PETERS indicating that he was five (5) minutes away.

A short time later the CS positively identified a 2003 red in color Cadillac Escalade as belonging to PETERS as it pulled into the parking lot. As the Escalade arrived the CS positively identified the driver of the vehicle as PETERS.

PETERS had previously agreed to meet the CS at the service access located at the north side of the building. Upon PETERS arrival in the parking lot, PETERS observed a white van with (2) subjects seated inside. PETERS departed the parking lot and drove away. Within minutes FETERS called the CS's phone. The phone call went unanswered by the CS. At the direction of law enforcement the CS made a controlled phone call to PETERS. During this phone call PETERS told

the CS that he had observed the white van with occupants and thought they were suspicious. The CS dispelled PETERS alarm and PETERS agreed to return to the store. Law Enforcement conducted mobile surveillance on Peters Escalade and followed him back the business. Peters was observed by Law Enforcement parking at the service entrance. The CS exited the service entrance and met with PETERS at his vehicle. PETERS removed a diaper box from his vehicle and gave the box to the CS. PETERS entered the service entrance followed by the CS who was carrying the box.

The CS set the diaper box down outside his office and PETERS entered the office to complete the drug transaction. PETERS was subsequently taken into custodyby law enforcement.

Law enforcement observed the diaper box to be taped closed with blue painter's tape. The box was bulging at the top and white plastic bags were plainly visible inside, foil packages consistent with appearance and packaging of synthetic cannabinoids. Upon closer inspection your Affiant observed foil packages labeled with the product name "Maui". The products observed were consistent with the same name brands and labeling of products obtained in earlier controlled purchases from the business that resulted in the presence of controlled substances per 893.03.

During a post-Miranda interview, PETERS, admitted his involvement in the sale, manufacture, and delivery of synthetic cannabinoids. PETERS admitted that he regularly brokers the sale of synthetic cannabinoids to the CS from another source of supply. PETERS stated he received a portion of the profits from each deal he brokered as payment for his services. PETERS acknowledged that Florida Attorney General, Pam Bondi, had recently issued bans on the substances that were used regularly in the manufacture of synthetic cannabinoids. PETERS stated he only brokered deals with the CS's store because all the previous clients stopped placing orders for fear of being targeted by law enforcement. PETERS stated he knew there was a "Gray area" when it came to the sale of these substances and stated it was "stupid" to be involved with them at all. PETERS stated he made a "bad decision" as it related to the practice of brokering the sale of these substances.

Based upon your Affiant's investigation, the Defendant, TIMOTHY S PETERS, did violate F.S.S. 893.13 (1a2) Possession of a Controlled Substance (to wit: synthetic cannabinoids) with Intent to Distribute. This offense did occur in Okaloosa County where your affiant is a bonded, full time, sworn law enforcement officer.
