## DESTIN MAN CHARGED WITH ATTEMPTED MURDER



The Okaloosa County Sheriff's Office took a Destin man into custody Monday night after his friend says he fired four shots at him inside a Gulf Shore Drive apartment.

43-year old Fred John Shepard of 775 Gulf Shore Drive, Unit 1009 is charged with attempted murder, shooting a firearm in an occupied dwelling, and using a firearm under the influence of alcohol.

Deputies were called to Shepard's apartment around 5:15 Monday evening after 41-year old Christopher Popelarski said Shepard came out of a bedroom following a nap and began shooting at him. Popelarski said three rounds from the handgun hit the couch where he was sitting and another hit a wall beside the front door as he was running away.

Shepard, whose blood alcohol level later tested at .22, denies firing at Popelarski. Popelarski says he does not know why Shepard was trying to shoot him. He says prior to Shepard taking a nap, the pair had just been talking and drinking together.

On 3/18/2013 at approximately 1715 hours the defendant, Fred John Shepard, intentionally discharged a

firearm at the victim, Christopher Popelarski. These offenses did occur within the dwelling at 775 Gulf Shore Dr. #1009 Destin, FL 32541.

Per an Affidavit of Compliant filed by the victim, the defendant did knowingly and intentionally fire three rounds from a .25 caliber semi automatic Phoenix Arms handgun at the victim while he sat on a couch in the dwelling. The rounds missed the victim, but did strike the couch the victim was sitting on. According to the victim, he ran to the front door in fear of his life. While the victim fled to the front door the defendant fired a fourth round in the direction of the victim. The fourth round missed the victim and struck the wall beside the front door.

The defendant had glassy red eyes and the odor of an alcoholic beverage on his breath. While at booking the defendant was tested for his alcohol breath content on the Intoxilyzer. The results of the breath samples were 0.222/0221.

Based on the above stated facts, I have reason to believe and do believe the defendant, Fred John Shepard, committed the offenses of Attempted Felony Murder, Shooting A Firearm Within An Occupied Dwelling, and Using A Firearm Under The Influence Of Alcohol. These are in violation of F.S.S. 782.051(2), 790.19, and 790.151 and did occur in
