DRUG TASK FORCE ARRESTS THREE IN MARY ESTHER

On March 21st, Okaloosa County Sheriff's patrol deputies responded to 208 Stephen Avenue, Apartment B, in Mary Esther in reference to a suspected domestic disturbance. Upon arrival, deputies made contact with Rashika L. Allen, a juvenile, and James C. Carswell. During the course of the disturbance investigation, deputies could clearly smell marijuana inside the residence and seized a small amount from Carswell which he had in his possession. Allen admitted to possessing a small amount of marijuana, which she voluntarily retrieved and provided to deputies.

Based upon this encounter with Allen, deputies believed that additional marijuana and/or contraband remained within the residence. Deputies requested for consent to search, which was declined.

Investigators from the Okaloosa Multi-Agency Drug Task Force were contacted, responded, requested and secured a search warrant for the residence.

During the time investigators were applying for and obtaining a search warrant, Allen and Carswell were detained in front of the residence. Carswell covertly used his cell phone to communicate and solicit another individual to come to the residence and surreptitiously remove items from within the house. These text messages instructed the individual to force entry to the back door, and remove items from four (4) specific locations.

While the deputies detained the two individuals out front, they would spot check the security of the residence, to include the rear. During one of these checks, deputies discovered Delanius E. Walker near the back door of the apartment. Walker observed law enforcement and began to rapidly walk away and was subsequently detained.

Deputies discovered a screw driver, fresh signs of attempted entry to the door. It is believed that Walker had communicated with someone and had arrived to remove or destroy evidence. Walker had a cell phone in his possession.

It was not until the approval and execution of the search warrant that deputies and investigators confirmed that the text messages had occurred.

During a search of the residence, investigators seized approximately 50 grams of cocaine,

40 grams of methylenedioxymethamphetamine (MDMA) also known as Ecstasy or Molly. These substances were found in specific locations identified in the text messages. (continued on page two)

A firearm (semi-automatic pistol) was found on an end table, near the living room couch, which was accessible and within reach ability of the 8-year old child.

James Carswell was arrested for Trafficking in Cocaine, Trafficking in Phenethylamines, Tampering with Evidence, and possession of marijuana

Rashika Allen was arrested for Child Abuse without great harm, possession of marijuana, and possession of drug paraphernalia

Delanuis Walker was arrested for Evidence/Destroying/Tamper and possession of a controlled substance.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On March 21, 2013, Okaloosa County patrol deputies responded to 208 Stephen Avenue, Apartment B., Mary Esther, Okaloosa County, Florida, in reference to a suspected domestic violence disturbance.

Upon arrival, deputies made contact with Rashika L. Allen and James Calvin Carswell who were inside the suspected disturbance, deputies smelled the odor of marijuana inside the residence. During this investigation, deputies discovered a small amount of marijuana in Carswell's possession. Allen also admitted having a small amount of marijuana inside the residence which she voluntarily retrieved for deputies. The marijuana Allen retrieved from the residence field tested positive for a controlled substance.

Based on their encounter with Allen, patrol deputies believed additional marijuana and/or contraband remained inside the residence. Deputies requested consent to search the residence, but Allen refused. The Okaloosa County Multi-Agency Drug Task Force (DTF) was summoned to assist in securing a search warrant for the residence.

Patrol deputies remained in front (outside) of the residence while DTF agents obtained the search warrant. During this period of time, deputies conducted a check to ensure the rear of the residence was secure and discovered Delanuis E. Walker near the back door of the apartment. Upon sight of law enforcement, Walker began to rapidly walk away from the door and was subsequently detained. Deputies discovered a screw driver on the ground directly below the rear door, scratch marks near the door knob, and paint flakes, that matched the color of the rear door, on the ground near where the screwdriver was found. Based on the circumstances, deputies believed that Walker was attempting to gain entry into the residence, while law enforcement officers stood guard in front, in an effort to remove and/or destroy contraband/evidence. Based on the circumstances, deputies believed that someone had communicated with Walker about the law enforcement activity at the residence. Deputies discovered that Carswell had his cellular telephone in his possession at this time.

After the search warrant was obtained, DTF agents responded to the residence to conduct the search. Upon arrival, DTF agents inspected text messages on Carswell's cellular phone and discovered communications which indicted he (Carswell) had solicited someone to remove suspected contraband believed to be stored inside the residence. The text messages instructed this individual, believed to be Walker, to force entry via the back door, then remove items from four specific places (oven mitt, coconut, refrigerator, pantry) within the kitchen of the residence.

During a subsequent search of the residence, approximately 50 grams of cocaine, approximately 40 grams of methylenedioxymethamphetamine (MDMA), and approximately 60 grams of marijuana, all of which field tested positive for controlled substances, were found in the previously described, specific locations within the kitchen of the residence, exactly as described in the text messages. It should be noted that the cocaine and marijuana were packed for distribution. A set of weighing scales, contaminated with cocaine residue, was also found inside the kitchen, along with packaging materials (plastic sandwich bags).

During a post Miranda statement, Carswell admitted the cocaine and MDMA found within the residence belonged to him. Carswell also admitted that he was involved in the distribution of the cocaine and MDMA for profit.

Carswell identified Rashika L. Allen as his girlfriend and verified that she was a marijuana user. Carswell

On 3/22/2013 I along with members of the Multi Agency Drug Task Force executed a search warrant at 1010 Rockport Drive Fort Walton Beach, FL, as it relates to a narcotics investigation. The suspect was identified as Delanius Walker.

During a search of the residence the following items were found inside: approximately 20 grams of crack cocaine and cocaine HCL packaged individually for distribution, large quantity of plastic baggies with cocaine residue, smoking devices commonly used to smoke marijuana, documents for Delanius Walker, and a 9mm Smith & Wesson handgun. It should be noted that the 9mm Smith & Wesson handgun was found inside of Walker's bedroom dresser drawer which also had documents for Delanius Walker next to it

Based on my knowledge, training, and experience the amount of crack cocaine and cocaine HCL found inside of the residence is indicative of a person involved in the distribution of cocaine and is not an amount commonly found in the possession of users of cocaine. I conducted a field test of the individual bags of suspected crack cocaine and cocaine HCL using a sterile cotton swab and liquid cobalt which provided a positive response for the presence of cocaine. It should be noted that a criminal history check revealed Walker was convicted of two (2) felony counts in April 2005 and is not supposed to possess weapons. An interview was conducted with Walker's girlfriend identified as Julia Grant who advised the dresser where the handgun was located is only used by Walker but stated that she has never actually seen Walker handle the firearm. Grant also advised that the garage is exclusively used by Walker which is where the crack cocaine and cocaine HCL was located. It should also be noted that Walker's residence is within 100 feet of the Boys and Girls Club located on Denton Boulevard and is within 700 feet of Choctawhatchee High School.

Based on the information and evidence obtained I have reason to believe and do believe the defendant Delanius Elliot Walker, did in fact violate F.S.S. 893.13 (1c1) possession of cocaine with intent to distribute within 1000 feet of a school and recreational facility; F.S.S. 790.23 (2a) possession of a firearm by a convicted felon, and F.S.S. 893.147 possession of paraphernalia. This offense did occur in Okaloosa County, Florida.
