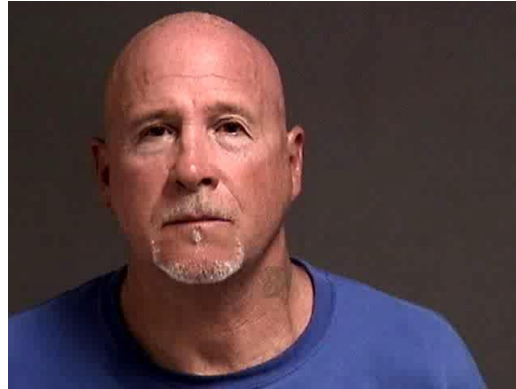

**REGISTERED SEX OFFENDER CHARGED WITH
LEWD AND LASCIVIOUS EXHIBITION**



The Okaloosa County Sheriff's Office arrested a Fort Walton Beach man who was found naked from the waist down at Oak Tree Nature Park in Mary Esther on March 24th.

Two brothers, ages 13 and 14, reported seeing a naked man riding a bicycle in the park where they were playing last Sunday. A deputy who went to investigate walked into the park, around a bend on a public trail, and found 58-year old Kenneth Ray Poore of 131 Patrick Drive Beach sitting on a bench, naked from the waist down. The deputy says when he asked Poore what he was doing, he just shrugged.

Poore, who is a registered sex offender, is charged with lewd and lascivious exhibition in the presence of a victim under the age of sixteen.



[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 4-24-13, an investigation was initiated in reference to lewd conduct in the Oak Tree Nature Park, Mary Esther Florida.

Victim 1 (14 YOA W/M) and his brother Victim 2 (13 YOA W/M) reported seeing a completely naked white male on a

bicycle in the Oak Tree Nature Park where they were playing. Both stated they had a clear view and saw his private parts (sexual organs).

The brothers gave me directions to where the suspect was last seen. I entered the park on foot and traveled at least 300 yards. I peeked around a bend on the public trail and saw a white male later identified as Kenneth Poore, matching the description provided by the children sitting on a public bench. His bike was resting on the side of the bench. Poore had a shirt on, but was completely naked from the waist down. His genitals were exposed and his legs were spread.

While I walked him out of the park we passed several people including children who were on the same trail.

Post Miranda he admitted he was not wearing anything from the waist down.

The suspect, Kenneth Ray Poore, is a registered Sexual Offender.

Based on my investigation I have probable cause to believe that Kenneth Poore violated the provisions of Florida State Statue 800.04.(7a2) Lewd and Lascivious Exhibition to wit, by intentionally exposing his genitals to persons less than 16 years of age. This incident occurred in a public park frequented by children and that children witnessed this act. This offense occurred in Okaloosa County, Mary Esther, Florida.
