

OCSO NABS TWO DURING SUSPECTED DRUG DEAL IN PROGRESS

The Okaloosa County Sheriff's Office has arrested two men on felony drug charges after a deputy spotted a suspected drug deal taking place in the parking lot of a fast food restaurant Tuesday night.

The deputy was in an unmarked car around 10:30 last night at the McDonald's on Highway 98 in Florosa when he saw a man get out of a Toyota, walk over to a BMW in the parking lot, get in the car, and count out money. The driver of the BMW then recounted the cash and produced a baggy containing pills.

Once the transaction was complete, the deputy made contact and arrested both suspects.

52-year old David Kirk Foy of Fort Walton Beach is charged with trafficking in opiates and possession of paraphernalia.

57-year old Thomas Neel Walker of Destin is charged with possession of a controlled substance and possession of paraphernalia.

Deputies confiscated approximately thirty various types of narcotic pills and more than \$1300.00 in cash.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 04/30/2013, you Affiant was parked at McDonalds at 2199 West U.S. Highway 98 and observed a green 2-doorToyota occupied by 3 (three) white males. A black 2-door BMW Z4 convertible with the top down pulled in a parking space between your Affiants and the green Toyota.

The front passenger (identified as Thomas Neel Parker) exited the Toyota and walked to the Black BMW and got into the front passenger seat. The driver of the Black BMW (identified as David Kirk Foy) then pulled the top up on the convertible and rolled up the windows.

You Affiant observed Parker removed the money from his pants pocket and counted it in front of Foy. Foy then took possession of the money, recounted it, and produced a plastic bag later found to contain 11 (eleven) 3-sided white pills with

an imprint of AZ 215. The pill was identified, via drugs.com, as Oxycodone Hydrochloride 30 mg.

When the drug transaction was completed and Parker exited the BMW, your Affiant exited the unmarked vehicle and identified myself as an Okaloosa County Deputy Sheriff and detained the occupants until back up arrived. The driver placed his hands on the steering wheel and Parker was handcuff.

Investigator J. Scott arrived and took charge of the passenger and your affiant made contact with Foy. Foy continued to move his hands and wanted to adjust his belt. Your Affiant then handcuffed Foy and he was searched. During the search your Affiant found a sandwich bag containing 3 (three) bags of 3-sided white pills with an imprint of EL 14. The pill was identified, via drugs.com, as Hydromorphone Hydrochloride 8mg and 1 (one) bag of round blue pills imprinted with A215 and 1 (one) bag of round white pills imprinted with 114. The pills were identified as Hydrocodone Hydrochloride 30 mg via drugs.com.

Also, found in the possession of Foy was \$1388 U.S. currency in street folds.

The total approximately weight of the pills is 44.5 grams.

David Kirk Foy was arrest for Trafficking in Opiates F.S.S. 893.135 (1c1) and Possession of Paraphernalia 893.147 (1).
