**MARY ESTHER MAN CHARGED WITH FELONY CHILD ABUSE  
AND AGGRAVATED BATTERY**



The Okaloosa County Sheriff's Office has charged a Mary Esther man with battery, aggravated battery on a pregnant victim, and felony child abuse. 26-year old Tory Mitchell Wright of 47 Brenda Lane was arrested Sunday evening.

Deputies say Wright punched a four-year old child in the stomach, and then pushed and hit his sister, 20-year old Delashay Campbell, after she intervened. Campbell is eight months pregnant.

Deputies say Campbell and the four year old child were not seriously injured.

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On 05-12-2013 I responded to 47 Brenda Lane, Mary Esther, Florida. In reference to a Disturbance In Progress.

Delashay Campbell the Victim stated in a Sworn Written Statement. That her Brother Tory Wright had hit [REDACTED] in the stomach with his fist after eating dinner. That started a verbal argument that turned physical. She stated that Tory pushed her twice then hit her in the face. While trying to collect her belonging to leave, Tory threw her items outside. Delashay has been living with Tory for the last two to three weeks. During initial contact Delashay's right eye had redness around it. Delashay is visibly eight months pregnant.

I spoke with the other Victim, four year old [REDACTED]. He verbally stated that [REDACTED] Tory punched him in the stomach. He said that caused him to fall down on the floor. [REDACTED] said it made him cry and that it hurt his belly. There were no signs of redness or injury.

I spoke with the witness Lynita Vaughn. She stated in Sworn Statement, that her son and daughter got into an argument over Tory punching [REDACTED]. While trying to leave Tory came outside and swung on Delashay and tried to hit her. She verbally stated that she saw Tory push and hit Delashay.

During a non- custodial interview I spoke with the Defendant Tory Wright. He stated verbally that he and his sister Delashay Campbell got in to an argument and he told her and other family members to leave the house. He stated his sisters boyfriend Tyree Jones intervened, and they started wrestling on the ground. He said his sister also jumped on top of him. He denied hitting anyone., and stated he was the victim. Tory had abrasions on both knees from rolling on the ground.

Based on my investigation, which included interviews with the victim, witness, suspect, I have reason to believe Tory Wright was the primary aggressor and did commit the offense of Battery (DOMV), F.S.S. 784.03(1)(A)(1), offense of Child Abuse Without Great harm, F.S.S 827.03.1, and the offense of Aggravated Battery were offender knew/or should of known victim was pregnant (DOMV), F.S.S. 784.045.1b.

This incident occurred in Okaloosa County Florida where your affiant is a sworn law enforcement officer.
