OCSO CATCHES CAR THIEF SUSPECT WHO RUNS STOP SIGN



An Okaloosa County Sheriff's Deputy who stopped a driver who ran a stop sign on Tuesday evening discovered the car had been reported stolen out of Fort Walton Beach.

21-year old Sakima Bracero of 1800 Old Ranch Road first made a spontaneous statement that the car was his girlfriend's. He later stated he "found it with the keys inside and thought it was his".

During a search, the deputy also found a red pill in Bracero's front pants pocket. He told the deputy it was candy, and then stated it was medicine but he didn't know what kind.

Bracero's been charged with grand theft of a motor vehicle and driving with no license. He was also cited for running a stop sign and failing to yield right of way. The car, A 2004 Dodge Neon, had been reported stolen by the Fort Walton Beach Police Department.

The red pill has been sent to the FDLE to determine if it is a controlled substance.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 5/7/13, I conducted a traffic stop in the area of Beal Parkway and Barks Drive, Fort Walton Beach, Florida. I first observed a blue Dodge neon, bearing Florida tag 523PYV traveling South on North Beal Extension. As I got behind the vehicle it pulled to the side of the road and then re-entered the travel lanes. As we approached the intersection of North Beal Extension and Beal Parkway the Dodge Neon went around a vehicle stopped at the stop sign and ran the stop sign while also failing to yield right of way to encoming traffic on Beal Parkway. I activated my lights and attempted the traffic stop. The vehicle eventually came to a stop in a parking lot on Barks Drive.

The driver attempted to exit the vehicle and I drew my department issued firearm. I advised the driver to stay in the vehicle and show me his hands. The driver complied and was subsequently taken into custody. The driver was identified as Sakima Bracero by his Florida identification card. Bracero made spontaneous statements that the vehicle was his girlfriends. He was then read his Miranda Warning from a prepared script. Bracero advised he understood and would speak to me. I asked him who's vehicle it was and he stated he found it with the keys inside and thought it was his.
