BAKER MAN CHARGED WITH AGGRAVATED BATTERY AND BURGLARY



A Baker woman who says she left her home November 16th to escape her abusive boyfriend says he showed up at a house where she was staying early this morning and beat her with a stick.

The Okaloosa County Sheriff's Office has charged 26-year old Joseph Fleming with two counts of aggravated battery with a weapon (one domestic violence related) and burglary.

25-year old Jadian Hatfield says Fleming repeatedly grabbed, pushed and slapped her at their home on Highway 189 in Baker on November 16th. She left and went to stay with a friend on Pickens Circle. Shortly after midnight this morning, Hatfield says Fleming forced his way into the house and began hitting her and her friend on their heads with a stick. Hatfield was taken to North Okaloosa Medical Center where she was treated and released. Deputies say along an injury to her head, her body was also covered with contusions on both legs, around her waist line, on her torso and both arms.



Deputies also charged 31-year old Athena Jeanell Griffith of Crestview with battery and burglary. They say Griffith went to the Pickens Circle home with Fleming and hit Hatfield in the upper chest and neck area.



[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 11/18/13 at approximately 0016 hours, I investigated a Burglary/ Agg. Battery at 1717 Pickens Cr Baker, Okaloosa County, FL.

Per verbal and sworn written statement/Affidavit of Complaint On 11/16/13 Jadian Faye-Marie Hatfield stated her live in boyfriend and father of her son Joseph Brandon Fleming repeatedly grabbed, pushed and slapped the victim within their home located at 6642 HWY 189N Baker, FL . She managed to leave the home and stayed with a friend at 1717 Pickens Cr. On 11/18/13 Mr Fleming and the Co-Defendant arrived at the Pickens Cr home and forced in the front door of the home and proceeded to the back bedroom where Ms. Hatfield and Mr Henderson where sitting and talking. The bedroom door was then forced in where Fleming proceeded to strike Mr Henderson in the top of his head with a stick causing a laceration and also struck Ms. Hatfield in the left side of her head with the stick.

Post Miranda Mr. Fleming stated he and the Co-Defendant never enter the home and they were attacked on

the front porch, which does not match the evidence at the scene of the crime.

Henderson was transported to North Okaloosa Medical Center and was treated for a laceration to the top head which did not require stitches. Hatfield sustained an injury to her head and displayed injuries consisting of numerous scrapes and contusions to her body from her previous altercation with Fleming.

Based on my investigation/physical evidence and statements provided, I have reason to believe and do believe Joseph Brandon Fleming, committed 2 Counts Aggravated Battery with weapon (1 DOMV) and Burglary. These are direct violations of F.S.S. 784.045(1a2) and 810.02(2a)

Per verbal and written statement/Sworn Affidavit, Whitney Blake Henderson and Jadian Faye-Marie Hatfield stated Hatfield's live in boyfriend and father of her son Co-Defendant and Athena Jeanell Griffith arrived at the Pickens Cr and forced in the front door of the home, proceeded to the back bedroom where Ms Hatfield and Mr Henderson where sitting and talking. The bedroom door was then forced in by the co-defendant where an altercation ensued. Upon the victim exiting the bedroom Ms Griffith proceeded to grab and strike her in the upper chest area and collarbone.

Post Miranda, Ms Griffith stated she and the Co-Defendant never enter the home and they were attacked on the front porch, contrary to the evidence at the scene of the crime.

Hatfield sustained injuries of numerous scrapes and contusions to her upper chest area.

Based on my investigation and statements provided, I have reason to believe and do believe Athena Jeanell Griffith did commit the offenses of Battery and Burglary. These are direct violations of F.S.S. 784.03(1a1) and 810.02(2a)
