# CONCERNED CITIZEN'S CALL LEADS TO DUI AND CHILD NEGLECT CHARGES



A concerned citizen called the Okaloosa County Sheriff's Office after spotting a woman speeding and driving erratically with a van door open and a child in a car seat next to the open door. Deputies located the van and made a traffic stop on Emerald Coast Parkway in Destin around 6:15 p.m. November 16<sup>th</sup> after noting that the driver could not stay in

one lane.

The deputy says on talking to the driver, 34-year old Marsha Jones of Santa Rosa Beach, he immediately noticed the smell of alcohol. He says Jones also seemed surprised when he asked about the open van door.

Jones was asked to do a Field Sobriety Test and subsequently arrested for DUI and child neglect without great bodily harm. She was also charged with resisting arrest without violence after failing to comply with commands. Once at the booking facility, Jones refused to submit to a breath test.

"We want to express our appreciation to the concerned citizen who took the time to relay to our agency that the van was swerving and a child was in a seat beside an open door," said Sheriff Larry Ashley. "We applaud their willingness to take action, helping bring to an end a dangerous DUI situation."

On November 16, 2013, at approximately 1842 hours, Marsha Diane Jones was arrested for violating F.S.S. 316.193 Driving under the Influence of Alcohol or Narcotics, F.S.S. 843.02 Resisting an Officer without Violence, and F.S.S. 827.03.2d Child Neglect without Great Bodily Harm.

On November 16, 2013, I initiated a traffic stop on a white, Mazda MVP van, bearing Florida Tag 174PNX, after the driver, Marsha Diane Jones, failed to maintain a single lane. This observation occurred after OCSO Dispatch received a complaint of the same vehicle driving erratically and speeding. The complainant also advised the passenger side, sliding door was open with a small child next to the door. During a subsequent investigation, I found Jones to be under the influence of alcohol and unable to safely operate a motor vehicle. Was secured in a car seat, in the passenger side of the second row of the vehicle. The sliding door on van was open while Jones drove on State Road 293 and US Highway 98, with the child adjacent to the open door and roadway, creating a hazard to the child and showing lack of care and supervision.

When I attempted to affect Jones' arrest for DUI and Child Neglect, she refused verbal direction after being ordered multiple times to comply. When verbal direction was ineffective, I secured Jones against the front of my patrol vehicle while continuing to give clear, concise, verbal commands. When this was ineffective, I advised Jones she would be taken to

#### INFORMAL REVIEW

The informal review shall consist solely of an examination of the materials submitted by you and the law enforcement officer or correctional officer.

#### FORMAL REVIEW

The formal review allows you to be heard and present witnesses in regard to this suspension/disqualification.
