SEARCH WARRANT LEADS TO TWO ARRESTS

Members of the Okaloosa County Sheriff's Office Street Crimes Unit executed a drug search warrant in the community of Sylvania Heights at 317 Sims Street, Lot A, in the Sylvania Heights community Thursday evening, October 24th.

Residents 50-year old Claudy Payne and 44-year old Sharron Hawkins were detained inside the home, along with five other subjects found to be loitering on the property. During the search deputies found evidence of the use of "crack" cocaine, including torn corner baggies with residue. Payne and Hawkins were arrested and charged with Public Nuisance (maintaining a place where narcotics are used, sold, or kept) and Possession of Narcotic Paraphernalia.

In addition, one of the subjects detained on the property, 19-year old Eddie Jackson of Bay Street in Fort Walton Beach, was taken into custody on an outstanding warrant of resisting arrest without violence.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On October 24, 2013 a lawful narcotics search warrant was executed at the residence located at 317 Sims Street Lot A, Fort Walton Beach, Florida.

Upon entry in to the residence the Defendant, Sharron A. Hawkins, was located in the living room where she was detained.

Search of the residence conducted and burned brillo pad used as a filter for the ingestion of "crack" cocaine and a broken suspected "crack" smoking pipe was located in the Defendant's bedroom which contained cocaine residue. Deputies also located clear plastic corner baggies in the garbage can located on the property. Said baggies contained a residue which tested positive for cocaine.

Post Miranda the Defendant admitted that she does smoke "crack" cocaine and acknowledged that she was aware that other subjects were involved in selling narcotics from the curtilage of her residence.

Post Miranda the Defendant admitted that he does smoke "crack" cocaine and added that he smokes approximately every other day. When questioned about other subjects selling narcotics which were being sold from the curtilage of his residence Payne admitted knowledge and added that he had also sold "crack" cocaine to make extra money. The Defendant added that if someone where to come looking for a "dime piece" worth \$10.00 he would obtain the "dime piece" and sell it for \$20.00.

Based on the aforementioned information I have reason to believe that the Defendant, Claudy L. Payne, did violate F.S.S. 823.10(1) Public Nuisance (maintain place where narcotics are used, sold, or kept) and F.S.S. 893.147(1) Possession of Narcotic Paraphernalia. These offenses did occur in Okaloosa County Florida.
