OCSO ARRESTS TWO IN DISCOVERY OF NICEVILLE METH LAB

Members of the Okaloosa County Sheriff's Office Multi-Agency Drug Task Force seized more than 500 grams of methamphetamine during execution of a search warrant Tuesday (September 10th) at a home in Niceville. Investigators discovered an active clandestine methamphetamine operation at 817 Spencer Place.

26-year old Christopher Michael Bagent and 38-year old Arden Lee Stanley, both of that address, are charged with trafficking in methamphetamine. Stanley, who is currently on probation for possession of controlled substance, told DTF members he's been cooking meth every day since October 2012 except for the 90 days he was in jail. Bagent is currently on probation for possession of methamphetamine and possession of drug paraphernalia.

response for the presence of methamphetamine.

The Defendant, CHRISTOPHER MICHAEL BAGENT, was located within the residence. After querying BAGENT through Meth Check, it was determined that on September 9, 2013 at 4:32 PM, BAGENT purchased one box of Allergy-D All Day 2,880 mg (2.88 grams of pseudoephedrine tablets) from the Walmart Pharmacy located at 1196 John Sims Parkway, Niceville, FL. The packaging for this box of pseudoephedrine was located within an arms reach of the suspected methamphetamine.

During the post-Miranda interview, BAGENT admitted that he is currently on probation with the Florida Department of Corrections for Possession of Methamphetamine and Possession of Drug Paraphernalia. BAGENT admitted that he did purchase a box of pseudoephedrine on September 9, 2013 from the Walmart Pharmacy. BAGENT admitted that he is still a methamphetamine user and last used methamphetamine three to four days ago.

During the post-Miranda interview with BAGINT'S co-Defendant, he stated that BAGENT purchased the pseudoephedrine from Walmart Pharmacy on September 9, 2013, and provided it so that methamphetamine could be cooked. BAGENT'S co-Defendant identified the package of pseudoephedrine located near the methamphetamine as the package BAGENT provided to conduct the methamphetamine cook.

Based upon your Affiant's investigation, there is probable cause to believe the Defendant, CHRISTOPHER MICHAEL BAGENT, did violate F.S.S. 893.135 (1F1) Trafficking in Methamphetamine (in excess of 400 grams) (principal). This offense is contrary to law, as such case provided, and against the peace and dignity of the State of Florida.

On September 10, 2013, members of the Okaloosa County Multi-Agency Drug Task Force executed a narcotics search warrant at 817 Spencer Place, Niceville, Florida. The search warrant was reviewed and approved by Assistant State Attorney Angela Mason. The search warrant was the read and signed by the Honorable T. Patterson Maney.

During a search of the residence, in excess of 500 grams of suspected methamphetamine was located. Precursor chemicals and paraphernalia used in the manufacture and use of methamphetamine were located throughout the residence and within the curtilage of the residence. The suspected methamphetamine was field tested rendering a presumptive positive response for the presence of methamphetamine.

The Defendant, ARDEN LEE STANLEY, was located within the residence. During the post-Miranda interview, STANLEY admitted that he is currently on probation for Possession of a Controlled Substance. STANLEY admitted that he had been cooking methamphetamine everyday since October 2012 with the exception of the 90 days he was in jail. STANLEY explained his method of cooking methamphetamine in detail. STANLEY claimed ownership of all the contraband located within his room and other locations within the residence. STANLEY stated his roommate/co-Defendant purchased the pseudoephedrine for this cook on September 9, 2013. STANLEY stated he regularly sells methamphetamine and trades boxes of pseudoephedrine in exchange for methamphetamine.

Based upon your Affiant's investigation, there is probable cause to believe the Defendant, ARDEN LEE STANLEY, did violate F.S.S. 893.135 (1F1) Trafficking in Methamphetamine (in excess of 400 grams). This offense is contrary to law, as such case provided, and against the peace and dignity of the State of Florida.
