# BATTERY SUSPECT WHO WENT FOR NIGHT TIME SWIM IN GULF TO ESCAPE DEPUTIES NOW IN CUSTODY



An Okaloosa Island man shot when he tried to attack an Okaloosa County Sheriff's Deputy in May is back in jail again on new charges of battery on a law enforcement officer, resisting arrest without violence, and battery.

The OCSO Fugitive Warrants Task Force tracked down 34-year old Eric Moore yesterday at his girlfriend's home in Fort Walton Beach.

Deputies had been searching for Moore since around 11:30 p.m. September 11<sup>th</sup>, when they responded to a call that Moore had battered a man and woman at an apartment on Billfish Avenue on Okaloosa Island. A deputy spotted the suspect, Eric Moore outside and attempted to handcuff him, but Moore pulled away and hit the deputy in the chest before running off.

Deputies chased Moore to the beach near 381 South Santa Rosa Boulevard, but Moore jumped into the Gulf of Mexico and began swimming. An OCSO boat and a Coast Guard vessel searched the waters for Moore while the Okaloosa Island Fire Department and additional deputies searched the beaches, but he was not located. Moore's van was later found to be missing. (Continued on page 2)

Warrants were issued for Moore and the OCSO Fugitive Warrants Task Force located him Thursday, September 12<sup>th</sup>, at 1022 Anniston Court. Moore initially hid in the attic and refused to come out of the home, but was eventually taken into custody.

Moore is the same individual charged with battery on a law enforcement officer and resisting arrest with violence in May after he fled from an OCSO deputy attempting to stop him for reckless driving in Mary Esther.

Moore ran behind the Lee Chrysler Dealership on Mary Esther Cut-off May 15<sup>th</sup>, and as the deputy was chasing him, he confronted her and attempted to punch her in the face.

The deputy fired her weapon, striking Moore once. During that incident, Moore said he was under the influence of Xanax, Valium, and possibly methamphetamine.

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On 09/11/2013 at around 2315 hrs the defendant, Eric Jacob Moore, was at his neighbors residence at 352 Billfish Ave. #12 Ft. Walton Beach, FL. While there the defendant got into a verbal altercation and then struck victims John and Richelle Huff with his fists, causing abrasions to various body parts on Mr. Huff, and some redness and swelling to the left side of Ms. Huff's face. According to the witnesses on scene this attack was one sided, and not provoked by either victim.

While investigating the incident I contacted the defendant in the parking lot of 352 Billfish Ave. The defendant handed me his GA ID, and told me he knew nothing about a fight. I told the defendant to put his hands on the truck we

were standing near, and he started to comply. I grabbed his right arm with my left hand, and as I did this the defendant aggressively pulled his arm away. I reached to grab him again, and as I did the defendant hit me square in my chest. My grasp on his wet arm failed again, and the defendant fled on foot. Deputy Sheriff Kyle Corbitt and I gave chase until the defendant dove into the Gulf of Mexico behind 381 S. Santa Rosa Blvd. After watching the defendant for approximately one hour, he disappeared under water and was not seen again.

Based on all of the above stated facts I have reason to believe and do believe Eric Jacob Moore committed the offenses of Battery on LEO, Resisting Arrest without Violence, and 2 counts of Battery. These are in violation of F.S.S. 784.07.2b, 843.02, 784.03.1a1, and did occur in Okaloosa County, FL where your affiant is a sworn Law Enforcement Officer.

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On May 15, 2013, the Okaloosa County Sheriff's Office received multiple calls in reference to a reckless vehicle in the Mary Esther area of Okaloosa County, Florida. Callers described the vehicle as a white work van.

Deputy Sheriff Elisa Tino responded to the area of the BOLO and after her and other deputies searched the general area, she observed the vehicle matching the description at the corner of Hollywood Boulevard and Mary Esther Cutoff. Deputy Tino observed the vehicle turn into the mall parking lot and caught up to the vehicle as it approached Mary Esther Cutoff from the mall parking. As the vehicle approached a stop sign in the mall parking lot Deputy Tino was able to provide OCSO Communications with the vehicle's Florida license plate number 1956BN. The vehicle crossed the southbound lanes and turned onto Mary Esther Cutoff heading north. Deputy Tino advised the vehicle was driving erratically and attempted to initiate a traffic stop near Mary Esther Cutoff and Page Bacon Road. Deputy Tino stated the vehicle continued to travel northbound at approximately 40MPH. Deputy Tino stated the vehicle entered a left turn lane and pulled into the Lee Chrysler Dealership where it came to a stop.

Deputy Tino advised OCSO Communications of their final location and then approached the vehicle. Deputy Tino approached the vehicle and asked the driver, later identified as the Defendant Eric Jacob Moore for his driver's license and vehicle information. Deputy Tino returned to her vehicle to conduct a check of the driver at which time he exited his

vehicle and fled away on foot. Deputy Tino notified OCSO Communications that the Defendant had taken off on foot and that she was in foot pursuit of him.

While attempting to pursue the Defendant, Deputy Tino advised she observed his arm pulled back with a closed fist as if he was going to strike her. Deputy Tino stated she remembered his fist touching her nose at which time she discharged two rounds at the Defendant striking him.

After the Defendant was shot, Deputy Tino attempted to render aid to the Defendant. The Defendant fled on foot again. Deputy A. Fitchett arrived on scene and deployed his taser in order to subdue the Defendant.

The Defendant made a spontaneous utterance that he was under the influence of Xanax, Valium, and possibly Methamphetamine.

I have reason to believe and do believe the Defendant is in violation of F.S.S. 784.07(2b), Battery on a Law Enforcement Officer and F.S.S. 843.01, Resisting with Violence. This offense did occur in Okaloosa County, Florida.

Deputy Sheriff Jeremy A. Gilbert is submitting this report as it pertains to a battery and battery on LEO incident in which Eric J. Moore is the suspect. Both of these incidents occurred at 352 Billfish Ave Ft. Walton Beach, FL.

On 09/11/2013 I was dispatched to 352 Billfish Ave #13 Ft. Walton Beach, FL regarding a battery in progress. Upon arrival I made contact with victims Richelle and John Huff (husband and wife), as well as witnesses Jackie Stacey and Adam Sheets. They all told me a male they know as "Eric" beat up both victims while they were at apt 11 just a few moments before we arrived on scene. Both victims were highly intoxicated and being very difficult to deal with, so I had OCSO Communications notify FD/EMS to examine their very superficial injuries, and then went outside and spoke with witness Stacey.

Ms. Stacey provided me with a verbal statement as well as a sworn written statement regarding this incident. She told me she was inside her apartment with her boyfriend, witness Adam Sheets, as well as "Eric", and victim Richelle Huff ("Ricky"). She said victim John Huff came up to her apartment looking for Ms. Huff, and started asking where she was. Ms. Stacey told him she was in the apartment, and he started asking her what was going on. She told him there wasn't anything going on, and all of a sudden "Eric" told Mr. Huff to go home. She said "Eric" then started a fight with both Huff's, and she tried to break it up. Ms. Stacey told me after the altercation "Eric" fled the area in his van as the Huff's went home to call law enforcement. Ms. Stacey said all of the involved parties, including herself, were intoxicated.

Mr. Sheets provided Deputy Sheriff K. Corbitt a verbal and written statement

about the incident. He told him Mr. Huff and "Eric" were drunk and started getting loud with each other. He said the altercation turned physical when "Eric" "jumped" on Mr. Huff. Mr. Sheets said after the altercation was over "Eric" departed in a white van.

According to Ms. Huff, whom eventually provided me with a sworn written affidavit of complaint as well as a verbal statement, "Eric" attacked her husband for no reason. She said her husband, whom is 64 years old, just had stomach surgery and wasn't able to defend himself, so she intervened in the fight to help him. Ms. Huff said at that point "Eric" struck her in the left eye, knocking her out and causing her to "see stars". She described "Eric" as a white male, scruffy beard, large build, with several tattoos on his upper body. I observed some very slight redness on the left side of Ms. Huff's face, as well as some swelling. Ms. Huff refused treatment to FD/EMS.

Mr. Huff also provided us with a verbal statement and sworn written affidavit of complaint. He told me he went to his neighbors residence (Adam and Jackie @ unit 12) and was confronted by "Eric". According to him "Eric" told him to leave, but he refused to do so. He told "Eric" he wasn't going anywhere until her talked to Adam. Mr. Huff said "Eric" then "sucker punched" him, and he went down to the ground. At that time he observed "Eric" punch Ms. Huff, so he "kicked him in the balls". Mr, Huff said he got up and chased "Eric" down the stairs, but he was able to get to a white van and flee. I observed some abrasions on Mr. Huff's knees, as well as on his forehead. Mr. Huff refused treatment to FD/EMS.

I went to my truck to get my digital camera, and as I did so I observed a white van in the parking lot. It was a van that I observed pulling into the parking lot shortly before me, and saw 2 males get out of the van. I didn't think the males were related to the call because OCSO Communications wasn't told by the victims that the van was realted. I asked Ms. Stacey if that was the van "Eric" got into, and she told me she wasn't sure but it did look like it. I walked over to the vehicle and ran the tag, FL 1956BN, through OCSO Communications. Per DHSMV the vehicle was registered to Eric J. Moore (suspect). As I was walking away from the van I observed a large frame white male approaching me. He matched Ms. Huff's description exactly. I approached him and asked him what his name was. He mumbled something, but I did not understand what he said. I asked him for an ID, and he told me he was in his swim trunks and didn't it with him. The male subject was soaking wet, but I observed a bulge in his left front pants pocket. I asked him a couple more times for his ID, and he was able to "find it" in his pocket. The GA ID card identified him as the suspect. I asked him to tell me about the fight upstairs and he told me he didn't know anything about it.

While talking to the suspect, I had D/S Corbitt walk over to my position. As he got about 30 feet from me I told the suspect to put his hands on the truck we were standing near, and he started to comply. I grabbed his right arm with my left, and reached for my handcuffs with my right. As I did this the suspect aggressively pulled his arm away. I reached to grab him again, and as I did the suspect hit me square in my chest. My grasp on his wet arm failed again, and the suspect fled on foot. D/S Corbitt and I chased him east on Billfish to Bluefish, and then south on Bluefish to Santa Rosa Blvd, and then he headed west. The suspect ran south across Santa Rosa Blvd and entered the western portion of The Breakers parking lot, which is located at 381 S. Santa Rosa Blvd. D/S Corbitt was closer to the suspect than me, so I entered the eastern side of The Breakers and ran to the beach. As I got to the back deck near the beach I observed the suspect attempting to run south over the dunes separating the deck from the beach. I ordered him to stop, but he refused to comply, so I gave chase again. The suspect ran south from the dune line and jumped into the Gulf of Mexico at about 2336 hrs.

I notified OCSO Communications of the situation, and requested a rescue boat be en route to our location. The suspect, whom appeared intoxicated and possibly high when I first encountered him, looked exhausted when he entered the water, and wasn't swimming very well south into the surf. D/S Corbitt and I kept our lights on him and kept OCSO Communications aware everything. Not long after he entered the water D/S T. Piaget arrived on scene, and I departed to get my 4wd vehicle. I arrived back within just a few minutes at about 2340 hrs. D/S Piaget stated he last observed the suspect at that time, and he was flailing his arms about 100 yards out, and went underwater. According to D/S Piaget the suspect never surfaced. He said he was almost strait out from the beach box on the west side of beach access 2. All of this information was relayed to the USCG boat that arrived on scene at about 0010 hrs. By that time we had 2 OCSO 4wd vehicles, an Okaloosa Island FD 4wd vehicle, and 2 Deputy Sheriff's on foot looking for the suspect. I even put a firefighter with a thermal imaging camera (TIC) in my patrol vehicle and we drove west from the point the suspect entered the water for about 1/2-3/4 of a mile (the current was flowing west and he was last seen swimming that way), but did not see him. We then turned around and drove almost to the Okaloosa Island Pier looking for him, and again met with negative results. We spoke with multiple people east and west of the point of entry, and none of them observed anyone emerging from the water. All of the people we spoke to were on the beach prior to our arrival, and had been out there the entire time. While we were doing all of this the USCG was using their night vision optics in an attempt to locate the suspect. After they searched for about 60 minutes the USCG advised they would be heading back to their station unless we had any further info for them.

I called Lt. Nix and gave him all of the information about the incident. He advised me the OCSO dive team is not equipped for a night operation at this time, and we would not be calling them out at that time. He told me to re-assess the situation during daylight, and then to notify D/S Culberson. All OCSO, FD, and USCG personnel were released from the scene at that time.

D/S Corbitt and I went back to the original scene and noticed the suspects van was still there, and the keys were inside of it. Since the van was not related to the crime and it was properly parked, it was not towed. At about 0515 hrs I drove back by the scene and the van was no longer present. At this time it is unknown if the suspect made it out of the water, or if the second unknown male subject took it. I also drove from the west end of the Okaloosa Island beach all the way to the Okaloosa Island Pier with negative contact with the suspect. I will have OCSO Communications send out a BOLO for the van and suspect.

Digital photos of the victims injuries will be submitted to OCSO evidence along with the suspects GA ID card. At this time the case will remain open until we can either recover the suspects body, or locate him somewhere.

Gilbert who was involved in a foot pursuit with a battery suspect. As I turned onto Santa Rosa Blvd, D/S Gilbert directed me to beach access two, and then to meet him and D/S Corbitt on the beach at the water's edge.

After getting to the water, I was able to see a white male approximately 100-150 out into the water. He appeared to be treading water in place, then began to move in a westerly direction parallel to the beach. Myself and D/S Corbitt shouted several times for the male to come toward the beach, he did not. After several minutes, the male could be seen splashing in the water, but periodically going under. While I was standing south/southwest of beach access two, in the vicinity of a white equipment box, the male was due south of me. After several minutes, the male went under the water and I did not see him resurface.

I walked along the beach to the west in an effort to locate the male. Approximately 1/4 mile west of beach access three, I spoke with four people who stated they had been there for approximately one hour. Each stated they did not see anyone exit the water, nor did they observe or hear anyone in the water.

This concludes my involvement in this case.

On 09/11/2013 at around 2315 hrs the defendant, Eric Jacob Moore, was at his neighbors residence at 352 Billfish Ave. #12 Ft. Walton Beach, FL. While there the defendant got into a verbal altercation and then struck victims John and Richelle Huff with his fists, causing abrasions to various body parts on Mr. Huff, and some redness and swelling to the left side of Ms. Huff's face. According to the witnesses on scene this attack was one sided, and not provoked by either victim.

While investigating the incident I contacted the defendant in the parking lot of 352 Billfish Ave. The defendant handed me his GA ID, and told me he knew nothing about a fight. I told the defendant to put his hands on the truck we were standing near, and he started to comply. I grabbed his right arm with my left hand, and as I did this the defendant aggressively pulled his arm away. I reached to grab him again, and as I did the defendant hit me square in my chest. My grasp on his wet arm failed again, and the defendant fled on foot. Deputy Sheriff Kyle Corbitt and I gave chase until the defendant dove into the Gulf of Mexico behind 381 S. Santa Rosa Blvd. After watching the defendant for approximately one hour, he disappeared under water and was not seen again.

Based on all of the above stated facts I have reason to believe and do believe Eric Jacob Moore committed the offenses of Battery on LEO, Resisting Arrest without Violence, and 2 counts of Battery. These are in violation of F.S.S. 784.07.2b, 843.02, 784.03.1a1, and did occur in Okaloosa County, FL where your affiant is a sworn Law Enforcement Officer.

On 9-12-13 a fugitive investigation was initiated on the suspect, Eric Moore. During the course of the investigation information was developed that the suspect was at his girlfriend's house located at 1022 Anniston Court in unincorporated Ft. Walton Beach.

A perimeter was placed on the residence and over the course of approx. four hours numerous attempts were made to contact the suspect, however he refused to exit the residence. While officers were regrouping and staging to make forced entry, the suspect and girlfriend exited the residence. The suspect was taken into custody without further incident.

An interview was conducted with the girlfriend, Tiffany Hale. Hale stated that early this morning, approx. 0100, the suspect contacted her from a friends phone and stated he needed a ride. Hale had to borrow her neighbors vehicle and drove to the area of Blue Fish Drive on Okaloosa Island. Upon her arrival she stated the suspect sped off in his van and drove to her residence.

Hale related that while law enforcement was knocking on the door, the suspect refused to let her out of the bedroom to answer the door. Hale stated further that the suspect blocked her path and told her not to answer the door. Hale stated she was in fear for her life and was afraid to answer the door. The suspect then climbed into the attic access to hide. Hale refused to sign an affidavit of complaint for false imprisonment. Hale and the suspect do not have any children in common and do not reside together so domestic violence charges were not an option.

The suspect was transported to booking for processing. No further information at this time.
